U.S. opioid lawsuits on verge of settlements with 4 companies



The yearslong effort by state and local governments in the U.S. to force the pharmaceutical industry to help pay to fix a nationwide opioid addiction and overdose crisis took a major step forward Tuesday when lawyers for local governments announced they were on the verge of a \$26 billion settlement with the nation's three biggest drug distribution companies and the drugmaker Johnson & Johnson.

Under the deal, Johnson & Johnson would not produce any opioids for at least a decade. And AmerisourceBergen, Cardinal Health and McKesson share prescribing information under a new system intended to stop the avalanches of pills that arrived in some regions about a decade ago.

Lawyers for local governments said full details could be shared within days. That would not be the end of the deal though; each state would have 30 days to decide whether to join. And local governments will have five months after that to decide. If governments don't opt in, the settlement total would go down.

"This is a nationwide crisis and it could have been and should have been addressed perhaps by other branches of government," Paul Geller, one of the lead lawyers representing local governments across the U.S., said in a conference call with reporters Tuesday. "But this really is an example of the use of litigation for fixing a national problem."

If approved, the settlement will likely be the biggest of many settlements to opioid litigation. While it means billions for lawyers who worked the cases, it is expected to bring more than \$23 billion to abatement and mitigation efforts to help get treatment for people who are addicted along with other programs to address the crisis. The money would come in 18 annual payments, with the biggest amounts in the next several years.

The deal echoes one the companies have been pushing, sometimes in public, for two years.

Johnson & Johnson reiterated in a statement that it's prepared to contribute up to \$5 billion to the national settlement.

"There continues to be progress toward finalizing this agreement and we remain committed to providing certainty for involved parties and critical assistance for families and communities in need," the company said. "The settlement is not an admission of liability or wrongdoing, and the Company will continue to defend against any litigation that the final agreement does not resolve."

But Cardinal Health declined to comment early Tuesday, and the other distribution companies did not respond to requests for comment.

In a joint statement, the attorneys general for Connecticut, Delaware, Florida, Louisiana, Massachusetts, New York, North Carolina, Ohio, Pennsylvania and Tennessee said the settlement talks with the four companies are "potentially nearing their completion," and that, "we look forward to bringing much-needed dollars home to our states to help people recover from opioid addiction and to fundamentally change the opioid manufacturing and distributing industries so this never happens again."

Even before the settlement plan was unveiled Tuesday, a group of public health advocates and experts began calling for any settlement money to be spent to address the opioid crisis.

"It's money that can do a lot of good if it's used well," said Joshua Sharfstein, a vice dean at the Johns Hopkins Bloomberg School of Public Health, who is spearheading the effort. "It's really important to use it well to save lives because it's coming at the peak of the overdose epidemic."

New York's deal, worth more than \$1 billion, represents the share of the national deal it will receive from distributors if the national deal is finalized. New York also reached a similar deal last month with Johnson & Johnson worth \$230

"Today, we're holding them accountable delivering more than \$1 billion more into New York communities ravaged by opioids for treatment, recovery, and prevention efforts," New York Attorney General Letitia James said in a statement Tuesday.

The trial is expected to continue, but the settlement leaves only three drug manufacturers as defendants.

Other manufacturers, regional distribution companies and pharmacies will remain in the New York and other cases for now. Closing arguments in a West Virginia trial against the distributors are expected to proceed as scheduled next week. The attorney general there, Patrick Morrisey, said the state would probably not agree to the terms.

The state and local governments say distribution companies did not have proper controls to flag or halt shipments to pharmacies that received outsized shares of powerful and addictive prescription painkillers. The companies have maintained they were filling orders of legal drugs placed by doctors — so blame for the nation's addiction and overdose crisis. An Associated Press analysis of federal distribution data found that enough prescription opioids were shipped in 2012 for every person in the U.S. to have a 20-day supply.



Big infrastructure bill in peril; GOP threatens filibuster

The bipartisan infrastructure deal senators brokered with President Joe Biden is hanging precariously ahead of a crucial Wednesday test vote as senators struggle over how to pay for nearly \$1 trillion in public works spending.

Tensions were rising Tuesday as Republicans prepared to mount a filibuster over what they see as a rushed and misguided process. With Biden preparing to hit the road to rally support for his big infrastructure ideas — including some \$3.5 trillion in a follow up bill — restless Democrats say it's time to at least start debate on this first phase of his proposals.

"It is not a fish or cut bait moment," said Senate Maiority Leader Chuck Schumer, D-N.Y., describing the procedural vote as just a first step to "get the ball rolling" as bipartisan talks

Six months after Biden took office, his signature "Build Back Better" campaign promise is at a key moment that will test the presidency and his hopes for a new era of bipartisan cooperation in Washington.

White House aides and the bipartisan group of senators have huddled privately since Sunday trying to wrap up the deal, which would be a first phase of an eventual \$4 trillion-plus package of domestic outlays — not just for roads and bridges, but foundations of everyday life including child care, family tax breaks, education and an expansion of Medicare for seniors.

Biden calls it a "blue-collar blueprint for building an American economy back." He asserted Tuesday that Americans are overwhelmingly in support of his plan and "that's the part that a lot of our friends on the other team kind of miss."

A core group of Republicans are interested in pursuing a more modest package of traditional highway and public works projects, about \$600 billion in new funds, and say they just need more time to negotiate with the White House.

Biden has been in touch with both Democrats and Republicans for several days, and his outreach will continue "until he has both pieces of legislation on his desk to sign them into law," White House Press Secretary Jen Psaki said Tuesday. While Biden proposes paying for his proposals with a tax hike on corporations and wealthy Americans who earn more than \$400,000 a year, the bipartisan group has been working almost around the clock to figure out a compromise way to pay for its package, having dashed ideas for boosting the gas tax drivers pay at the pump or strengthening the Internal Revenue Service to go after tax scofflaws.

Instead, senators in the bipartisan group are considering rolling back a Trumpera rule on pharmaceutical rebates that could bring in some \$170 billion to be used for infrastructure.

Some senators want to delay the vote to Monday. "We're making progress, but we need more time," said Sen. Susan Collins, R-Maine, one of the members of the bipartisan group.

By setting the vote now, Schumer is trying to nudge negotiations along, a strategy both parties have used before. If it fails Wednesday he can set another vote to proceed to the bill later.

Many Republicans are wary of moving ahead with the first, relatively slim package, fearing it will pave the

way for the broader \$3.5 trillion effort Democrats are preparing to pass on their own under special budget rules that only require 51 votes. Vice President Kamala Harris can break a tie. Meanwhile, House Speaker Nancy Pelosi has been working to keep restless Democrats in her chamber in line, as rank-and-file lawmakers grow impatient with the sluggish Senate pace. Liberal Democrats, in particular, are eager to make gains on Biden's priorities — with or without Republicans.

"Time's a wasting, I want to get this work done," Rep. Pramila Jayapal, D-Wash., the chairwoman of the Congressional Progressive Caucus, told reporters Tuesday.

Trump inaugural committee head accused of being UAE agent

LOS ANGELES (AP) — The chair of former President Donald Trump's 2017 inaugural committee was arrested Tuesday on charges alleging he conspired to influence Trump's foreign policy positions to benefit the United Arab Emirates and commit crimes striking at what prosecutors described as "the very heart of our democracy."

Tom Barrack, 74, of Santa Monica, California, was among three men charged in federal court in Brooklyn, New York, with conspiring to act as an unregistered foreign agent as they tried to influence foreign policy while Trump was running in 2016 and later while he was president.

Besides conspiracy, Barrack was charged with obstruction of justice and making multiple false statements during a June 2019 interview with federal agents. Also charged in a seven-count indictment were Matthew Grimes, 27, of Aspen, Colorado, and Rashid al Malik, 43, of the United Arab Emirates.

"The defendants repeatedly capitalized on Barrack's friendships and access to a candidate who was eventually elected President, high-ranking campaign and government officials,

"Worse, in his communications with Al Malik, the defendant framed his efforts to obtain an official position within the Administration as one that would enable him to further advance the interests of the UAE, rather than the interests of the United States," prosecutors wrote in a letter seeking his detention.

Authorities said Barrack served as an informal adviser to Trump's campaign from April 2016 to November 2016 and chair of the Presidential Inaugural Committee from November 2016 to January 2017. Beginning in January 2017,

he informally advised senior U.S. government officials on Middle East foreign policy, they added.

Authorities cited several specific instances when Barrack or others allegedly sought to influence U.S. policies, noting that, in May 2016, Barrack inserted language praising the UAE into a campaign speech Trump delivered about U.S. energy policy and emailed an advance draft of the speech to be delivered to senior UAE officials.

"Similarly, throughout 2016 and 2017, the defendants sought and received direction and feedback, including talking points, from

senior UAE officials in connection with national press appearances Barrack used to promote the interests of the UAE," authorities said in a statement.

They said that after one appearance in which Barrack repeatedly praised the United Arab Emirates, Barrack emailed al Malik. saying: "I nailed it... for the home team," referring to the UAE.

Phone and email messages sent to the UAE Embassy in Washington were not immediately returned.

Barrack will plead not guilty, according to a spokesperson.

"Mr. Barrack has made himself voluntarily available to investigators from the outset," the spokesperson said.

Grimes also was arrested Tuesday in Southern California. A message seeking comment was sent to his attorney.

Bill Coffield, an attorney for al Malik who was not in custody Tuesday said his client had cooperated extensively with the office of special counsel Robert Mueller and that there was "nothing new here." He said that al Malik had simply tried to foster a good relationship between the country where he was born "and the country in which he lives and works, both of which he loves."

Climate envoy says US, China must end world's 'suicide pact'

LONDON (AP) — U.S. climate envoy John Kerry called on China to join America in urgently cutting greenhouse gas emissions and described the international alliances that rebuilt Europe after World War II as a model for fighting against climate change.

Kerry challenged global leaders to accelerate the actions needed to curb rising temperatures and pull the world back from the edge of the abyss. "Allies, partners, competitors and even adversaries" must work together, he said during a speech at London's Kew Gardens, a UNESCO World Heritage site where scientists are working to protect plants from global warming.

"The climate crisis is the test of our own times, and while it may be unfolding in slow motion, to some, this test is as acute and as existential as any previous one," Kerry said. "Time is running out." Kerry described the next decade as decisive, saying countries around the world must speed up efforts to reduce greenhouse gas emissions if they are to meet their commitment to

limit temperature increases to no more than 1.5 dearees Celsius over pre-industrial levels.

While many countries have pledged to eliminate net carbon emissions by 2050, Intergovernmental the Panel on Climate Change says emissions must be cut by at least 40% by the end of the decade to keep temperatures in check.

Organizers of the next Unit-

are calling the November event in Glasgow, Scotland "the world's last best chance to get runaway climate change under control."

The primary goal of the meeting, known as COP26, is for countries to set "ambitious" targets for reducing greenhouse gas emissions by 2030.

To meet these targets, countries need to phase ed Nations climate summit out the use of coal, reduce

deforestation, accelerate the shift to electric vehicles and encourage investment in renewable energy, according to the conference organizers. China, the United States and India are the world's biggest emitters of greenhouse gases, meaning efforts to control climate change are likely to fail unless all three lead the way in slashing emissions. Kerry referred to the often tense relationship between the U.S. and China but said the future depended on their cooperation. Both countries also need to raise their ambitions, he said.

"It is not a mystery that China and the U.S. have many differences. But on climate, cooperation is the only way to break free from the world's current mutual suicide pact," he said. "President Biden and President Xi have both stated unequivocally that each will cooperate on climate despite other consequential differences. America needs China to succeed in slashing emissions. China needs America to do the same.''

China's output of climatewrecking pollution surged in the last decade as its economy boomed, especially as it kept operating, building and financing new, dirty-burning coalfired power plants.

The Rhodium Group analysis firm reported in May that China as of 2019 was pumping out more than 27% of all climate-damaging emissions globally. That's more than the United States, which stood at 11%, and more than the rest of the developed world combined, Rhodium said.

France probes use of NSO spyware; Macron a possible target

PARIS (AP) — The cellphones of French President Emmanuel Macron and 15 members of the French government may have been among potential targets in 2019 of surveillance by spyware made by the Israel-based NSO Group, according to a newspaper report Tuesday.

The report by Le Monde follows an announcement by the Paris prosecutor's office that it is investigating the suspected widespread use of NSO's Pegasus spyware to target journalists, human rights activists and politicians in multiple countries.

Le Monde is part of a global media consortium that identified the targets from a leaked list of more than 50,000 cellphone numbers obtained by the Parisbased journalism nonprofit Forbidden Stories and the human rights group Amnesty International and shared with 16 news organizations which began publishing their findings on Sunday.

That same day, Amnesty released a forensic analysis of the alleged targeting that showed Amazon Web Services was hosting NSO infrastructure. In response, Amazon said it shut down NSO accounts that were "confirmed to be supporting the reported hacking activity." Amazon said they had violated its terms of use.

Another U.S. company identified by Amnesty as hosting NSO servers was DigitalOcean. When contacted by The Associated Press, DigitalOcean neither confirmed nor denied whether it had identified or cut off such servers.

"All of the infrastructure outlined in the Amnesty report is no longer on DigitalOcean," it said Tuesday without elaborating in an emailed statement.

Le Monde said the phone numbers for Macron and then-government members were among thousands allegedly selected by NSO clients for potential surveillance. In this case, the client was an unidentified Moroccan security service, according to Le Monde.

Consortium members said they were able to link more than 1,000 numbers on the list with individuals, including more than 600 politicians and government officials and 189 journalists.

Among the numbers were those of journalists and politicians in France. The largest share were in Mexico and the Middle East, where Saudi Arabia is reported to be among NSO clients.

Also on the list were phone numbers in Azerbaijan, Kazakhstan, Pakistan, Morocco and Rwanda, as well as ones for several Arab royal family members, heads of state and prime ministers, the consortium reported.



Haiti arrests 3 cops, awaits new chief, while mourning Moïse

PORT-AU-PRINCE, Haiti (AP)

 Haitians held official ceremonies Tuesday to honor assassinated President Jovenel Moise while preparing to install a new interim leader and arresting at least three police officers implicated in the killing.

Designated Prime Minister Ariel Henry was to be sworn in to replace interim Prime Minister Claude Joseph, who assumed leadership of Haiti with the backing of police and the military after the July 7 attack at Moise's private home. A crowd of international dignitaries and Haitian officials clad in somber suits sat under the shade of pink and white bougainvillea to commemorate Moise in the yard of the Nation Pantheon Museum in Port-au-Prince.

A large portrait of the slain president hung behind Joseph as he spoke to mourners. "The president is dead because of his political and social convictions," he said. Joseph accused oligarchs and criminals of assassinating the president's character and then the president himself. He called on everyone to seize the moment as an opportunity to find a

common purpose and durable, viable solutions.

Moïse was shot multiple times and his wife was seriously wounded, and while officials have arrested at least 26 people in the case, it remains unclear who ultimately was behind the attack. Police Chief Léon Charles announced four more formal arrests on Tuesday at least three of them he did not release.

"There was infiltration in the police," he said.

Authorities earlier said they had detained and isolated but not formally arrested several high-ranking police officials as they tried to determine why the attackers were able to reach the president without any of his guards being injured.

Henry, a neurosurgeon and police officers, whose ranks former cabinet minister,

was scheduled to be sworn in on Tuesday afternoon after promising to form a provisional consensus government to lead Haiti until elections are held. "We will need this unity to overcome the many challenges that beset us," Henry said. "Some have observed the latest events with amazement, others wonder with reason about the management of the country."

Henry said he has met with various unidentified actors as well as civil society and the private sector. "I intend to continue and deepen these discussions, because it is the only way to bring the Haitian family together," he said.

The government released the names of Henry's Cabinet, with the ministers of justice, economy, finance, agriculture and others keeping their positions.

Haiti Elections Minister Mathias Pierre told The Associated Press on Monday that Joseph would step down and cede the position to Henry, who was chosen for the post by Moïse shortly before he was killed but had not been sworn in. The change in leadership comes after a group of key international diplomats called on Henry to create a "consensual and inclusive government" in a statement issued Saturday that made no reference to Joseph. The Core Group is composed of ambassadors from Germany, Brazil, Canada, Spain, the U.S., France and the European Union as well as representatives from the United Nations and the Organization of American States.





Nordstrom pivots as shopper habits change during pandemic

Like many of its peers, venerable department store chain Nordstrom is having a tough time keeping pace with customer demand for new clothes because of supply issues.

That will be an even bigger challenge heading into the full swing of its anniversary sale, a tradition since the 1960s. Last year, customers stayed away because there was no reason to buy dressy clothes during a pandemic. But Nordstrom is framing this year's event as an opportunity for shoppers to reinvent themselves as they come out of their homes. Amid product delays, the retailer says it developed a back-order feature on its website for customers who want to take advantage of the sale but find the item not in stock.

Jamie Nordstrom, president of Nordstrom stores and great-grandson of company founder John W. Nordstrom, recently spoke with The Associated Press at its Manhattan store to share some thoughts about changing shopper habits, shipping delays and why the Seattle-based Nordstrom plans to pack up masks soon. The interview has been edited for clarity

and length.

Q. What kind of delays in merchandise shipments are you seeing?

A. Anywhere from a couple of days to a month. And you don't really always know exactly what's causing it. Is it the port in Asia? Is it the port at Long Beach where ships anchored out there can't get offloaded. We're retailers. We're focused on serving customers. We've got a great team that's focused on the inbound supply chain. And whether it's come to Nordstrom store,

a few days or a couple of weeks, we're ready to roll with the punches on that.

Q. Anything left of the CO-VID-19 safety measures?

A. In most cities and markets we do business in, we are able to do the full makeover in our beauty departments and in our spas. That was probably one of the last things that we're able to unlock. But we want customers to know and it's been this way for quite a while now that when they they're getting the full experience. It's not a watered-down COVID version of Nordstrom.

Q. What's the customer traffic like?

A. It has been very different across the regions. It started in the South South Florida, Texas over the last several months. It's the states that dropped the restrictions first is where traffic started to build. And then as you moved North and West, as states dropped restrictions, we saw that traffic come

back pretty quickly. And so we're encouraged by the path that we're on and the pace that customers are coming back in.

Q. What makes the anniversary sale extra important this year?

A. More than anything, it's a wardrobe refresh. People have discovered comfort. They don't want to sacrifice style. There's a big demand out there for people to really go through their closets and kind of reinvent how they want to look over the next couple of seasons.

Q. Which trends from the pandemic will remain and how are you reacting?

A. So casual, athleisure, denim. We are scrambling to get after what the new suit is. It may not be the same suit that it was. It's a sport coat and it's a pair of jeans. It's an interesting time to try and react to very quickly changing customer needs.

Q. What's not coming back?

A. Maybe masks. We've been selling a lot of masks the last year and a half. We're not selling a whole lot right now, which is a good thing. And so I think maybe we'll pack those masks away, and hopefully we'll never have to bring them out again.

Jeff Bezos blasts into space on own rocket: 'Best day ever!'

VAN HORN, Texas (AP) — Jeff Bezos blasted into space Tuesday on his rocket company's first flight with people on board, becoming the second billionaire in just over a week to ride his own spacecraft.

The Amazon founder was accompanied by a hand-picked group: his brother, an 18-year-old from the Netherlands and an 82-year-old aviation pioneer from Texas the youngest and oldest to ever fly in space.

"Best day ever!" Bezos said when the capsule touched down on the desert floor in remote West Texas after the 10-minute flight.

Named after America's first astronaut, Blue Origin's New Shepard rocket soared on the 52nd anniversary of the Apollo 11 moon landing, a date chosen by Bezos for its historical significance. He held fast to it, even as Virgin Galactic's Richard Branson pushed up his own flight from New Mexico in the race for space tourist dollars and beat him to space by nine days.

Unlike Branson's piloted rocket plane, Bezos' capsule was completely automated and required no official staff on board for the up-and-down flight.

Blue Origin reached an altitude of about 66 miles (106 kilometers), more than 10 miles (16 kilometers) higher than Branson's July 11 ride. The 60-foot (18-meter) booster accelerated to Mach 3 or three times the speed of sound to get the capsule high enough, before separating and landing upright

During their several minutes of weightlessness, video from inside the capsule showed the four floating, doing somersaults, tossing Skittles candies and throwing balls. Cheering, whooping and exclamations of

"wow" could be heard. The capsule landed under parachutes, with Bezos and his guests briefly experiencing nearly six times the force of gravity, or 6 G's, on the way back.

Led by Bezos, they climbed out of the capsule after touchdown with wide grins, embracing parents, partners and children, then popped open bottles of sparkling wine, spraying one another.

"My expectations were high and they were dramatically exceeded," Bezos said later

Their flight lasted 10 minutes and 10 seconds five minutes shy of Alan Shepard's Freedom 7 flight in 1961. Shepard's daughters, Laura and Julie, were introduced at a press conference a few hours later.

Sharing Bezos' dream-come-true adventure was Wally Funk, from the Dallas area, one of 13 female pilots who went through the same tests as NASA's all-male astronaut corps in the early 1960s but never made it into space.

"I've been waiting a long time to finally get it up there," Funk said after the flight. "I want to go again fast," she added.

Joining them on the ultimate joyride was the company's first paying customer, Oliver Daemen, a last-minute fill-in for the mystery winner of a \$28 million auction who opted for a later flight. The Dutch teen's father took part in the auction, and agreed on a lower undisclosed price last week when Blue Origin offered his son the vacated seat.

Among the items brought on the flight: A pair of aviator Amelia Earhart's goggles and a piece of fabric from the original Wright Flyer."I got goose bumps," said Angel Herrera of El Paso, who watched the launch from inside Van Horn High School, about 25 miles (40 kilometers) away.

Chance the Rapper to bring secret concert to the big screen

LOS ANGELES (AP) — When Chance the Rapper filmed a secret concert four years ago, he intended to make a movie for the big screen but ended up shelving the project after not knowing how to edit all the footage. But while hunkered down in his home during the pandemic, the Grammy winner took the opportunity to educate himself about the craft of filmmaking. Chance hosted and performed in several virtual concerts including "Chi-Town Christmas" which he wrote and directed giving him enough confidence to revisit the idea of making his own film.

"I had a lot of editing notes and ideas, but I didn't know how to edit," he recalled. "But during the pandemic, I started doing virtual concerts and actually directina them myself. I picked up all these skills that filmmakers have one of them was figuring how to edit and work with editors. I needed that." Now, Chance's filmmaker aspirations are coming into fruition with his concert film "Magnificent Coloring World," which premieres

Aug. 13 in select AMC Theatres. The concert was filmed in his hometown of Chicago during his Magnificent Coloring World Tour in 2017, shortly after winning three Grammys through his 2016 independent project "Coloring Book," which won best rap album. The project became the first streaming-only album to win the award. He also

took home the best new artist trophy and best rap performance for his sona "No Problem" featuring 2 Chainz and Lil Wayne.

The concert film will celebrate the five-year anniversary of "Coloring Book."

Chance could have gone the streaming service route, but he elected to pitch his concert film idea to AMC Theatres a few months ago with hopes of immersing moviegoers into his full concert experience.

"There's just something different about going to see something in theaters, instead of watching it in your bed or whatever," he said. "I always knew that I wanted this to be experienced in a group and on a huge screen with crazy surround sound." Chance led

the film's editing process and self-distributed the film through his House of Kicks umbrella, which reimagines music, film and virtual experiences.

His partnership with the theater chain marks the first time a music artist has independently distributed a film through AMC.

"The appreciation Chance's dazzling creation is a genuine demonstration of the power and emotional connection audiences have with Chance, and how they feel while watching his work on the big screens of AMC," said Adam Aron, CEO and president of AMC Entertainment said. "This is a reminder of the uncharted programming possibilities at AMC, and we are thrilled to blaze this path with Chance The Rapper and his team."

"Magnificent Coloring World" features a variety of stages designed by Chance and was filmed on a soundstage within three and a half weeks. The rapper said he wanted to tell a unique story with each frame with the help of director Jake Schreier, who directed the 2015 film "Paper Towns."

With another major, Morikawa charting new path


Add another name with whom Collin Morikawa is now linked by his remarkable run through the majors in a span of 343 days. This one is a little out of left field, but it speaks to how much Morikawa has achieved in his short time on the PGA Tour.

He will be the first player since Andy North in 1985 to make his debut in the Ryder Cup having already won two majors.

It was different back then, of course. Tour players had to serve an apprenticeship before they could even become PGA of America members and be eligible. North won the U.S. Open twice before playing in his first Ryder Cup.

"I think it was three years before you could start getting Ryder Cup points," North said Tuesday. "And then you had to go through a three-day school. We had to take a rules test. That's why a lot of players didn't play in as many Ryder Cups as you would think."

Nicklaus, for example, had already won seven majors when he played his first Ry-

der Cup.

"He is special," North said, turning his thoughts back to Morikawa. "I was around him quite a bit at the PGA Championship because no one was there. He was the most mature, ready player that I've seen in long, long time." There were a lot of obscure records that came along with that silver claret jug he won at Royal St. George's. Not since Jones

has a player won two professional majors in eight starts or fewer. Nicklaus, Woods, Spieth and Rory McIlroy are all on the list of having two majors before turning 25.

Nicklaus won two of those when trailing after 54 holes, just like Morikawa.

The numbers are equally impressive: A closing 64 to win the PGA Championship at Harding Park last August,

a 66 on the final day to win the British Open on Sunday. He played his last 23 holes of the PGA and his last 31 holes at the Open without a bogey.

And he took his own place in the record book as the first man to win two majors in his first time playing them. His calm, his polish, his poise would suggest Morikawa is never in a hurry. His record indicates otherwise. And his

wisdom was evident Saturday night when he was asked about playing in the final group at a major for the first time.

"I've never been in the position all the other previous times," he replied.

Everything is new. And then he makes everything seem old hat.

Morikawa still thinks back to the dinner he had with Justin Thomas on the eve of his pro debut in June 2019. Thomas assured him that while every path is different some short, some longer talent is never denied. Morikawa won in his sixth start. Winning two majors in two years elevates Morikawa to among the elite in golf, and he'll face even more attention and scrutiny next week at the Olympics, and at Whistling Straits for his first Ryder Cup.

If there are lessons to be learned — he has proven to be adept at that — it's to reset the goals. That's what he feels he failed to do when he won the PGA Championship last year.

"I'm not going to throw everything into the trash and just say, 'OK, we're a completely different person.' But goals have to change," Morikawa said. "I didn't do that last year."

Joshua defending heavyweight titles vs Usyk in September

LONDON (AP) — Anthony Joshua will defend his WBA, IBF and WBO heavyweight titles against former undisputed world cruiserweight champion Oleksandr Usyk at Tottenham Hotspur Stadium on Sept. 25.

The fight pits two 2012 London Olympic gold medallists against each other: Joshua topped the podium in the super-heavyweight division and Usyk reigned supreme in the heavyweight bracket.

"We are two Olympic gold medallists who have fought our way to the top and never avoided challenges," Joshua said in a statement on Tuesday. "The stadium is exceptional, the atmosphere will be electric, I'm honored to be

such an awe inspiring venue. I am ready to handle business."

Tom Brady, champion Buccaneers visit Biden at White House

WASHINGTON (AP) — Tom Brady embraced his inner comedian to deliver jokes at old friend Donald Trump's expense Tuesday when he and the Super Bowl-winning Tampa Bay Buccaneers visited President Joe Biden at the White House, the first visit by the reigning NFL champions since 2017.

The seven-time Super Bowl champion who once was gifted a "Make America Great Again" hat from Trump that he displayed in his locker at Gillette Stadium compared those backing Trump's false assertion that he won the 2020 election to people who couldn't believe the underdog Buccaneers beat the Kansas City Chiefs.

"Not a lot of people think that we could have won, and in fact I think about 40% of the people still don't think we won," Brady said. "You understand that, Mr. President?"

"I understand that," Biden responded.

Brady also played off Trump's derisive "Sleepy Joe" nickname for Biden when talking about a time he forgot what down it was. "I lost track of one down in 21 years of playing, and they started calling me 'Sleepy Tom,'" Brady said with a grin. "Why would they do that to me?"

It was Brady's first visit since 2005 with the New England Patriots when George W. Bush was in office. Brady has won the Super Bowl during four different administrations but skipped visits by the Patriots in 2015 with

Barack Obama and 2017 with Trump. The Patriots as a team chose not to attend after winning in 2019. Brady was front and center this time, one of 42 Bucs appropriate since Tampa players accompanying Biden, coach Bruce Arians and owner Bryan Glazer to the ceremony, which included more than just his jokes. There was some pointed political commentary from Arians and a push from the president for players to get vaccinated against the coronavirus if they hadn't already.

Arians quickly shifted from extolling his Buccaneers' guiding principles of "trust, loyalty, and respect" that focused the team on "one team, one cause" to taking an indirect dig at Republican lawmakers on Capitol Hill who have opposed el-

ements of the president's agenda. Biden was presented with the traditional gift of a No. 46 jersey which Glazer said was Bay is heading into its 46th season as a franchise. With the sun beating down in the late morning, Biden told players to take their suit jackets off following a group picture, but those in attendance next to the Lombardi Trophy didn't mind. "I know the guys really, really enjoyed it, even with the heat," said Arians, who's eager for the Buccaneers to get their Super Bowl rings Thursday and move on to next season with training camp opening next week. "I just told them it's another work day. We got to get a workout in today, so standing in the

sun's a good one."

Before baking in the sun, players Donovan Smith and Bradley Pinion from the team's social justice committee met with Vice President Kamala Harris to talk about voting rights, a subject the Buccaneers have prioritized.

"It feels like it gives us validity or the weight of some of the stuff that we were doing in Tampa, especially around voting and getting people to vote," offensive lineman Ali Marpet said after the ceremony. "As an organization we're really trying to be leaders in (that area), and that was a big point of emphasis for her." Talking about how nearly 200,000 vaccine doses were given out at Raymond James Stadium the Buccaneers' home coach to win it all.

and where they won the Super Bowl — Biden turned to dozens of players behind him and said: "If you don't have a shot, get one, OK? Get one, get one, get one. You're saving lives, helping us get back to our lives and our loved ones."

Biden also lauded NFL efforts to promote COVID-19 vaccinations.

White House press secretary Jen Psaki did not directly answer when asked if the Buccaneers provided information on which team attendees were vaccinated. Over half of their traveling party of players coached and staff has been fully vaccinated, and while 10 NFL teams as of Friday had reached the 85% threshold it's unclear if Tampa Bay was one of them.

Biden in his prepared remarks singled out receiver Chris Godwin, like himself Pennsylvania-born Delaware-raised, who he spoke with before the Super Bowl.

"I wasn't expecting it, so it definitely took me by surprise," Godwin said afterward. "He gave me a call the day before the Super Bowl, and I was shocked then. We chatted, had a five-, 10-minute talk, talked about Delaware a little bit and he wished me good luck. That was an honor for me. Then he was kind enough to send me a letter afterwards congratulating me on the win and congratulating the team."
