

Hegseth says he wants the Pentagon to prioritize speed over cost when buying weapons

WASHINGTON (AP) - Defense Secretary Pete Hegseth said Friday the Pentagon is revamping how the military buys weapons, shifting the focus away from producing advanced and complex technology and toward products that can be made and delivered quickly.

Hegseth, speaking to military leaders and defense contractors in Washington, said the "objective is simple: transform the entire acquisition system to operate on a wartime footing, to rapidly accelerate the fielding of capabilities and focus on results."

Hegseth gave his address, which ran for more than an hour, at the National War College. It delved much more into military minutia than a previous big speech to hundreds of military leaders abruptly summoned to a base in Virginia, where he declared an end to "woke" culture and announced "aender-neutral" directives for troops.

Hegseth acknowledged the granularity Friday, saying, "If folks are watching this on Fox, their eyes are

rolling over."

The defense secretary argued his changes are meant to move the military away from the more traditional process that prioritized delivering a perfect, if expensive and late, product in favor of something that is less ideal but delivered quickly. Some experts say the changes could mean less transparency and the military ending up

with systems that may not function as expected.

"An 85% solution in the hands of our armed forces today is infinitely better than an unachievable 100% solution ... endlessly undergoing testing or awaiting additional technological development," he said. He asserted that what used to take several years could happen within one.

The shift is coming as Rus-

sia's grinding war has seen an underfunded Ukraine using cheap, mass-produced drones to effectively hold off a technologically superior Moscow, which is armed with advanced missiles and hundreds of tanks. "Drones are the biggest battlefield innovation in a generation, accounting for most of this year's casualties in Ukraine," Hegseth argued in a July memo be-

fore declaring that "while global military drone production skyrocketed over the last three years, the administration previous deployed red tape." That memo lifted some Pentagon restrictions on drone purchases.

Todd Harrison, a defense budget and acquisition expert at the American Enterprise Institute, said Hegseth's ideas represent a significant shift in how the military would buy arms.

But he warned that if contractors aren't incentivized "to check all the boxes" for everything the military wants in a product, "they may deliver something faster, but it may not do what you want it to do."

The way the U.S. military buys weapons and platforms has faced criticism for various reasons for decades. In recent years, the most famous example of the Pentagon's failure to get the right gear to the front line was the scores of troops that died from roadside bombs in Iraa and Afghanistan because of poorly armored vehicles that weren't designed for the conflict.

Trump accuses foreign-owned meat packers of inflating U.S. beef prices and calls for investigation

owned meat packers of The Republican president driving up the price of beef in the U.S. and asked the Department of Justice to open an investigation.

announced the move on social media days after his party suffered losses in key elections in which the winning Democratic candidates focused relentlessly on the public's concerns about the cost of living.

"I have asked the DOJ to immediately begin an investigation into the Meat Packing Companies who are driving up the price of Beef through Illicit Collusion, Price Fixing, and Price Manipulation," Trump wrote in the social media post.

"We will always protect our American Ranchers, and they are being blamed for what is being done by Majority Foreign Owned Meat Packers, who artificially inflate prices, and jeopardize the security of our Nation's food supply," he continued.

Trump offered no proof to support his allegations.

"Action must be taken immediately to protect Consumers, combat Illegal Monopolies, and ensure these Corporations are not criminally profiting at the expense of the American People," he said.

Last month, Trump suggested the U.S. would buy Argentine beef to bring down stubbornly high prices for American consumers, angering U.S. cattle ranchers. Beef prices have soared in part after drought and years of low prices led to the smallest U.S. herd size

in decades. Trump's tariffs on Brazil, a major beef exporter, have also curbed imports.


Trump's accusations have renewed a bipartisan presidential fight against rising food prices.

Then-President Joe Biden talked with independent farmers and ranchers about initiatives to reduce food prices by increasing competition within the meat industry.

And then-Vice President Kamala Harris, who Trump defeated in winning reelection last year, used her campaign to vow to crackdown on food producers and major supermarkets " price gouging."



The government shutdown prompts the cancellation of some **Veterans Day events**

Normally on Veterans Day, volunteers gather at the Riverside National Cemetery in California to place flags alongside more than 300,000 gravesites. But not this year.

The longest federal government shutdown on record is curtailing and outright canceling parades, cer-

emonies and other events across the U.S. that are normally held to mark Veterans Day. It's another fallout of the shutdown that has disrupted flights and food assistance, and was already being squarely felt by military families who are worried about their paychecks.

In California, organizers of "A Flag for Every Hero" said they couldn't move forward with the event on Tuesday without access to restrooms, traffic control and other needs for the thousands of participants. Elsewhere, a lack of federal employees and access to military facilities has scrubbed other Veterans Day events.

"We have a responsibility to provide them the resources

they need, and unfortunately with the shutdown we're unable to do that," Laura Herzog, founder and CEO of Honoring Our Fallen, which organizes the Riverside National Cemetery

Many communities will still hold Veterans Day gatherings, including some of the nation's largest and wellknown events such as the annual observance at Arlington National Cemetery in Virginia and the New York Veterans Day Parade. The disruption to a federal holiday that is intended to honor those who have served in the armed forces comes as military families face uncertainty week to week about their pay. The Trump administration has found ways to pay troops twice since the shutdown began Oct. 1.

The Texas National Cemetery Foundation canceled an annual Veterans Day event at the cemetery in Dallas-Fort Worth, saying organizers wouldn't have time to stage the ceremony even if the shutdown ended soon. In Virginia, city leaders in Hampton cited concerns about a lack of servicemembers to participate in its annual parade because of the shutdown.

"Our veterans deserve to be recognized with great pomp and circumstance," Hampton City Manager Mary Bunting said in a news release. "Without the presence of our active-duty military, we are concerned that the parade would appear sparse and that the recognition might fall short of the honor our veterans so richly deserve."

Organizers of Detroit's annual Veterans Day parade say they're moving forward with the Sunday event, but it won't include an appearance by a U.S. Army band or a helicopter flyover. Others are relying on even more help from volunteers than usual to make up for the lack of federal resourc-

The Wyoming Valley Veterans Day Parade, which has been a tradition in Wilkes-Barre, Pennsylvania, every year since 1945, will still take place Sunday. But organizers have had to scramble because of the shutdown, asking veterans to participate. And instead of military vehicles, the parade will feature motorcycle groups and car clubs.

ICE to open national call center to find unaccompanied migrant children amid surge in partnerships

U.S. Immigration and Customs Enforcement plans to open a national call center to help local and state law enforcement agencies find unaccompanied migrant children who entered the country illegally, according to a federal contracting document released this week.

ICE said it has an "immediate need" to establish an around-the-clock call center in Nashville, Tennessee, capable of handling 6,000 to 7,000 daily calls to help law enforcement with "locating unaccompanied alien children."

ICE seeks to open the call center by the end of March and be fully operational by June. It requests information on the number of interested vendors and what technology they can use to "maximize call efficiency." ICE also issued another notice seeking information on vendors able to transport thousands of detainees daily from across Texas, where a new state law taking effect next year mandates all counties with a jail enter into ICE partnerships. The proposed call center and transport programs come as the government

pours \$170 billion into immigration and border security following the passage of the Republican Party's big bill which President Donald Trump signed into law in July. There has been an explosion of partnerships with local and state law enforcement agencies to enforce immigration laws. The Trump administration's immigration crackdown has also included several policy changes focused on unaccompanied minors and ramped up attempts

2,000 unaccompanied children were in government custody as of July. An unaccompanied migrant child is defined by the U.S. government as someone who is under 18, lacks lawful immigration status and has no parent or guardian in the country to take custody of them.

Hundreds of thousands of unaccompanied minor children have traveled to the U.S. southern border in recent years. When they

enter the country, Border Patrol transfers the children to the care of the Office of Refugee Resettlement which houses them in a network of shelters across the country. They can be released from the shelter system to stay with sponsors who are generally parents, relatives or family friends.

The Trump administration has been conducting a nationwide review of the 450,000 migrant children who crossed the U.S.-Mexico border without their

parents during President Joe Biden's term. Federal agents have intensified scrutiny on migrant children's sponsors, requiring them to submit to DNA tests and fingerprinting among other measures. While the administration has said these efforts are intended to ensure the safety, migrant advocates are dubious given Trump's zero-tolerance approach to immigration and mass deportation agenda.

The ICE notice did not specify why the greater Nashville area was chosen as the intended site. But CoreCivic Inc., one of the largest private detention contractors in the U.S., is headquartered there. The company, which has donated millions to GOP candidates at all levels of government, has benefited from a surge in ICE contracts.

A spokesperson for CoreCivic spokesperson did not comment on whether it would be contracted for the call center.

ICE is also searching for vendors capable of transporting detainees from anywhere in Texas, including hospitals, private residences and traffic stops, to one of 36 different ICE offices within 30 minutes.

House cleaner shot to death on front porch after going to wrong house in Indianapolis suburb

Authorities are considering whether to charge an Indiana homeowner who they say shot and killed a woman working as a house cleaner after she mistakenly went to the wrong address.

Police officers found 32-year-old Maria Florinda Rios Perez De Velasquez dead just before 7 a.m. Wednesday on the front porch of the home in Whitestown, an Indianapolis suburb of about 10,000 people, according to a police news release. She was part of a cleaning crew that had gone to the

wrong address, the release said.

Rios Perez's husband,

cleaning homes for seven months. Velazquez said he was standing with her at the home's front door on Wednesday morning but didn't realize she had been shot until she fell into his arms, bleeding.

On a fundraising page, her brother described Rios Perez as a mother of four children. Police said Friday that she was from Indianapolis but the family plans to bury her in Guatemala, according to her obituary and her brother's fundraising page. The Associated Press was not able to reach family members directly on Friday.

Authorities have not pub-

licly identified the shooter. Police turned over the findings from their investigation to Boone County Prosecutor Kent Eastwood on Friday afternoon, but the prosecutor said the decision on whether to file charges won't be easy.

The case brings Indiana's castle doctrine laws squarely into play, he said. Those laws allow a person to use reasonable force, including deadly force, to stop what they reasonably believe is an unlawful entry into their dwelling. Thirtyone states have similar laws on the books, according to the National Conference of State Legislatures.



Denmark's government aims to ban access to social media for children under 15

Denmark's government on Friday announced an agreement to ban access to social media for anyone under 15, ratcheting up pressure on Big Tech platforms as concerns grow that kids are getting too swept up in a digitized world of harmful content and commercial interests.

The move would give some parents after a specific assessment the right to let their children access social media from age 13. It wasn't immediately clear how such a ban would be enforced: Many tech platforms already restrict preteens from signing up. Officials and experts say such restrictions don't always work.

Such a measure would be among the most sweeping steps yet by a European Union government to limit use of social media among teens and younger children, which has drawn concerns in many parts of an increasingly online world.

Speaking to The Associated Press, Caroline Stage, Denmark's minister for digital affairs, said 94% of Danish children under age 13 have profiles on at least one social media platform,

and more than half of those under 10 do.

"The amount of time they spend online the amount of violence, self-harm that they are exposed to online is simply too great a risk for our children," she said, while praising tech giants as "the greatest companies that we have. Stage said a ban won't take effect immediately. Allied lawmakers on the issue from across the political spectrum who make up a majority in parliament will likely take months to pass relevant legislation.

"I can assure you that Denmark will hurry, but we won't do it too quickly because we need to make sure that the regulation is right and

that there is no loopholes for the tech giants to go through," Stage said. Her ministry said pressure from tech giants' business models was "too massive."

It follows a move in December in Australia, where parliament enacted the world's first ban on social media for children setting the minimum age at 16.

That made platforms including TikTok, Facebook, Snapchat, Reddit, X and Instagram subject to fines of up to 50 million Australian dollars (\$33 million) for systemic failures to prevent children younger than 16 from holding accounts.

Officials in Denmark didn't say how such a ban would be enforced in a world where millions of children have easy access to screens. But Stage noted that Denmark has a national electronic ID system nearly all Danish citizens over age 13 have such an ID and plans to set up an age-verification app. Several other EU countries are testing such apps.

"We cannot force the tech giants to use our app, but what we can do is force the tech giants to make proper age verification, and if they don't, we will be able to enforce through the EU commission and make sure that they will be fined up to 6% of their global income."

EU tightens visa restrictions on Russians over the Ukraine war and acts of sabotage

BRUSSELS (AP) — The European Union on Friday made it harder for Russian citizens to enter Europe's ID-check free travel area due to Russia's continued war on Ukraine, increasing acts of sabotage blamed on Moscow and the potential misuse of visas.

Russian nationals can no man rights defenders, and worthy tourists when there longer get multiple-entry visas into the so-called Schengen area, which is made up of 25 of the 27 EU member countries, plus Liechtenstein, Iceland, Norway and Switzerland.

They will now have to apply for a new visa each

time they travel to Europe, "allowing for close and frequent scrutiny of applicants to mitigate any potential security risk," said the EU's executive branch. the European Commission. Exceptions will be made for people "whose reliability and integrity is without doubt" like dissidents, independent journalists or hutor close family members of Russians living in the EU or family members of EU citizens living in Russia.

"We now face unprecedented drone disruptions and sabotage on our soil," EU foreign policy chief Kaja Kallas said in a statement

Russian Foreign Ministry spokeswoman Maria Zakharova bristled at the decision. "The European Commission apparently figured: 'Why does Western Europe need creditare illegal migrants living on benefits and Ukrainian draft dodgers?'"

The EU suspended its "visa facilitation agreement" with Russia after the fullscale invasion of Ukraine in 2022 and decided to "deprioritize" the granting of making it more time con-

Mexico president's rivals cry foul as she uses groping incident to address gender violence

By FABIOLA SÁNCHEZ **Associated Press** MEXICO CITY (AP) — The groping of Mexico President Claudia Sheinbaum on a downtown street shone a bright light on the gender violence women face every day, but the country's political polarization has tarnished what under other circumstances would seem a natural moment for national solidarity, analysts say.

The president has tried to use the assault to send a clear message that such behavior is not acceptable. She has explained why she decided to press charges against the drunk man; she used her bully pulpit to pressure the remaining states that don't have sexual harassment on the books as a crime; and she talked about the need to make it easier for women to report such crimes.

"A political distraction"

Sen. Alejandro Moreno, leader of the opposition Institutional Revolutionary Party, condemned violence against women, but in the same breath accused Sheinbaum's Morena party of using the incident as a "political distraction" from the mayor's killing.

Uruapan Mayor Carlos Alberto Manzo Rodríguez was killed last Saturday, shot by a 17-year-old who died at the scene, in what authorities said was an organized crime plot. On Wednesday, his widow met with Sheinbaum at the National Palace and later was sworn in to finish out his term.

On Tuesday, Sheinbaum was walking from the National Palace to the Education Ministry for a meeting when she stopped to speak with some citizens.

SOFIA, Bulgaria (AP) — A van carrying nine migrants who entered Bulgaria illegally crashed while being chased by police near the country's eastern Black Sea coast, killing six of the migrants, officials said Friday. The incident occurred near the city of Burgas shortly before midnight Thursday as police tried to stop the van, which had Romanian registration plates, Border Police Chief Anton Zlatanov told reporters. He said the driver repeatedly refused to stop at the signals given and, eventually, attempted to evade spike strips set by the police. The driver lost control and the van slipped off the road, overturned and plunged into a lake bordering the highway, killing six migrants at

Four others, including the Romanian driver, sustained minor injuries and were given first aid at the scene and then taken to a hospital.

Preliminary information suggested that the migrants were from Afghanistan.

Bulgaria, a Balkan country of 6.5 million, is located on a major route for migrants from the Middle East and Afghanistan to Europe. Only a small number of them plan to stay in the EU's poorest member, using Bulgaria instead as a transit corridor on their way westward. Zlatanov said that over the past two years up to 20 organized criminal groups involved in migrant trafficking have been neutralized.



A quick snack for the road

Learn how to make the Aruban Pastechi!

(Oranjestad)—If you ever been using or on a clean surface with to Aruba before, you probably heard of (and even tried) the Aruban Pastechi. Beloved by young and old, this tasty treat is a staple for party snacks, a quick lunch or even breakfast!

Here's how to make the Pastechi dough.

Ingredients:

- 4 cups of wheat flour
- 1 tbsp baking powder (if using self-rising flour, omit baking powder)
- 1 tsp salt
- 1 tbsp sugar
- 0.5 cup of melted butter
- 1 cup water
- 1 egg

Directions:

Sift your flour into a bowl and add all the dry ingredients before giving it a quick mix. Next add the butter, water and egg and mix until thoroughly combined. At this point, your dough will start to get sticky; time for an arm workout. Knead

some flour lightly dusted until its surface is smooth. You'll know your dough is ready when it doesn't stick to your hands or the surface on which you're kneading it. Let your dough rest covered for 15-20 minutes.

After resting, divide your dough into approximately 100 gram balls and roll it flat with a rolling pin. The thickness of the pastechi depends on your taste, but the average thinness would be around 1/4 inch or so.

Filling for the pastechis varies according to your taste. The easiest and most common filling you'll find in Aruba is a simple cheese fillina. For this, we usually use shredded Gouda, but feel free to use any cheese that melts well when frying the pastry.

Place the filling on your rolled out piece of dough, fold it in half and pinch the sides shut with a fork. If you have a folding tool, feel free to your dough into the bowl you are use it for this process. Your pastechi



is ready for the fryer!

If you want to store some pastechis for later use, you can freeze them. A good tip is to place a piece of wax paper in between each pastechi if you are to store them on top of one another. This way the pastechis don't stick to each other when defrosting.

Here in Aruba we enjoy pastechi at any time of the day, but it has become almost tradition to eat pastechis for breakfast on the way to work. Many roadside snack trucks sell pastechi from early mornina to noon, and offer a variety of fillings like cheese; ham and cheese; ground beef and pulled chicken to name a few.

Another Treasure of Aruba's Beaches: Sea Glass!

It is hard to imagine this happening today, but years ago people dumped all kinds of refuse straight into the ocean, including old cars, and their household garbage, which of course included lots of glass. Over the next 30 years the pounding waves cleaned the beach, by breaking down everything but glass and pottery. The pounding waves washed the trash up and down, back and forth. Tons of polished, broken glass pieces were created by the pounding surf. These smoothened, colored glass particles then settled along the sea shore in millions, and that is why you can find these beautiful and colorful pieces on the north shore beaches of Aruba.

Especially on the strip on white sand between the famous Natural Bridge" and the huge red anchor close to "Grapefield" beach you will be able to find your own pieces of sea glass. The sea glass that was created is the product of a very long and interesting process.

It can take anywhere from

10 to 30 years to make sea glass.

The name for any piece of glass that finds its way to the ocean and tumbles around in the water long enough is "Sea glass.

The colorful pieces of glass are being used for decoration, handcrafts and jewelry!

Once glass makes its way into the ocean, the glass is broken up into shards and is tumbled around in the water, where sand and other rocks act like sandpaper to smooth out its rough edges. Sometimes as the sea glass is passed through fire, it becomes fire glass, the rarest of sea glass with certain inclusions, just like precious gems.

For years, the water beat against the different kinds of trash being dumped. Glass, household appliances and even motor parts were discarded on the beach. The waves and weather conditions wore down the overwhelming amount of garbage in the water, creating millions of beautiful smooth rocks.

It's hard to believe the short-

sighted mistakes we were making that could have potentially ruined these beautiful beaches. But thanks to natural processes, the ocean transformed the trash into the sea glass.

Each colored gem on the beach has its own story.

The ruby red glass stones are typically from old car tail-lights.

Then, the sapphire rocks are the remnants of broken apothecary bottles. The most common and the easiest to find are the brown (Amstel & Polar beer), green (Heineken & Balashi beer) and clear glass which are the soft much loved "soft drink" bottles.

If you like to see the sea glass for yourself, and be in awe of the power of nature, rent a car or jeep and go explore our deserted beaches on the north side of the island. Make it a fun family day!

Even if we didn't mean to pollute the Beaches how we did, it is inspiring to see just how the earth can correct our mistakes.

Funny, how trash can change into treasures!

Everybody knows that you are not allowed to take local shells home, but the people working at the airport have no problem you taking sea glass home. A few of those pieces make great souvenirs. You can place them in a wine glass or large bottle for decoration and every time you look at it a smile will light up your face thinking back of your unforgettable Aruba vacation!

Located further east to the Natural Bridge and Andicuri Beach, the Blackstone Beach is relatively easy to access. Once you get passed the Ayo Rock Formation, take the Andicuri road leading up to Andicuri Beach. There, you can park your car and take a 1km hike towards Blackstone Beach.

This beach forms part of the Arikok National Park and is therefore a site that is preserved. This is why it is also relatively untouched by commercial influences. Despite being called a beach, do note that it is not advised to swim in the water, as the current is very strong and can easily stray you further in the wild ocean. However, you can still enjoy a spectacular view of the stones and the northern ocean that stretches out in front of the beach and take a picture with your friends or family!

Aruba's Nature is to be Cherished

The national park Arikok comprises almost 18 % of the island. Its rugged terrain, desert-like hills filled with tall cacti, breathtaking coastline and protected local flora and fauna welcome you to be explored. There is numerous wildlife to discover like for example the sea turtle who lays his eggs on the park's beaches. There are more places on the island that are a preserved area like the Bubali Plas which is a bird sanctuary.

Did you know that four of the in total seven species of sea turtle lay their eggs on Aruba's beaches? In the national park, a Least Tern (Sternula antillarum) keeps a strict eye on a very special event taking place below on the beach: a majestic



Leatherback (Dermochelys coriacea) heads back to sea after laying her eggs, while another nest laid 2 months ago by the same female hatches. A very rare occurrence of daytime nesting and hatching. Sea turtles prefer nesting in the cool and dark hours of the night. And hatchlings usually wait for the cue of cooling surface sand before emerging.

Bubali Magic

This beautiful close-up image of the pink bird is courtesy of Michiel Oversteegen of the Aruba Birdlife Conservation. This important foundation showcases and builds awareness of Aruba's

birds and other native flora and fauna. You may have seen a 'pink cloud' lately at the Bubali or Spanish Lagoon Wetlands areas? It's most likely to be Roseate Spoonbills (Ajaia ajaja) or 'Chucharon Cora' as they are known in Papiamento. This unusual looking bird forages in shallow muddy water while sweeping its flattened bill from side to side to catch small fish, crustaeceans and other aquatic invertebrates. The Roseate Spoonbill remains an uncommon sight as they are vulnerable to degradation of feeding and nesting habitats (Wetlands). (Source: arikok national park)

The Bali Restaurant: a touristic hot spot and lost gem on the island

(Oranjestad)—Once located in what is now the Renaissance Marina, the Bali Restaurant was once both a touristic and local hot spot, and nowadays it's considered a forgotten gem on the island.

Known as "the floating restaurant", Bali first opened in 1955 by Willem "Bill" Strijland, who had experience in Javanese cuisine. At the time, the restaurant was pretty exclusive—with space to host only 25 guests. Yet, 4 years later, it was named the best restaurant in the Caribbean by the Caribbean Tourist Association.

The restaurant was probably most iconic for its

Javanese-inspired exterior with its pointy, slanted roofs. However, the first version of Bali did not look like that at all but was still considered as one of the most popular restaurants on the island at the time. The restaurant saw three different owners during its existence, during which it underwent various renovations and rebranding.

In 1964, the restaurant was taken over by Karel "Carl" Schmand. Over the years, the restaurant needed constant renovation and repair, mainly due to its vulunstable pillars underneath the foundation. However, the biggest change made to the restaurant happened

in the year 1970—still under the ownership of Schmand, when it got its iconic pointy roofs. The restaurant was also expanded to host a total of 85 guests. This was "The New Bali", who had its official (re) opening in 1972.

After 1972, when Ronny Schmand took over, the restaurant saw vet another expansion; this time complete with a long bar and dance floor, where guests enjoyed live music from legendary Aruban musician and composer, Toti Arends.

The Aruban way of life; Creating community with Cas di Torto

(Oranjestad)—The Aruban people understand that a happy life is spent in great ambience with your loved ones. Passed down from one generation to the other, building community has been a key aspect in forging our traditions and customs. The Cas di Torto (mud house) played a big role in cultivating community, bridging families together and forming close bonds with your neighbors—something we highly value today.

Cas di Torto: History and construction

The origin of the Cas di Torto is said to date back to the early 19th century in the Paraguana Peninsula in Venezuela. Refugees who sought sanctuary on Aruba introduced this building method to the island.

The uprights of the walls were made with sturdy and straight wayaca or kwihi wood, or from thin mangrove struts. Then, the wattle walls were weaved in using branches and twias from the warero and sisal plant, daubed with a mixture of grass and mud. Finally, the walls got a coat of white plaster to seal everything in.

For roofing, corn stalks, palm fonds and straws were used, allowing air to flow freely through the house. This method of roofing was known throughout the ABC islands



(Aruba, Curacao, Bonaire), but the use of cornstalks in Aruba eventually got replaced with use of mud and white plaster for the roofs. The white plaster all around made the houses looks like cake, hence the name "Torto" (Spanish for "cake").

Building community

Building Torto houses was often a community effort.

Young couples who were about to get married had to have their house built before they could tie the knot and start their own family. This is where the help of the community comes into play.

Neighbors, extended family and friends would all help in the construction of a Torto House. And everyone had a role: The men oversaw the



building of the house, and the women were tasked with collecting wood and straws, cooking and taking care of the little ones.

The couple's family were primarily responsible for feeding everyone who helped build the house. Before construction, someone usually had the task to prepare the meal; going fishing or slaughter farm animals like goats, chicken or sheep. Even the older kids had their tasks; the older children of the family usually helped with collecting water and mixing the mud.

The average duration of constructing a Cas di Torto was 4 months.

At the end of a long day of work, everyone would gather around and enjoy a feast of hearty food. This type of help from friends and family became a tradition and was called "paga lomba": You help me today; I'll help you tomorrow.

Nowadays, traditional Cas di Torto are rare, especially those that are still inhabited. Houses that do exist probably date back more than a century.

How Aruban beaches came to be!



(Oranjestad)—We've talked about the best beaches to visit on the island before, but have you ever wondered how Aruba got its white, sandy beaches, and why there's a clear difference between the northern

and southern shores? Here are some fun facts about the development of Aruban beaches.

How did Aruba get its white, sandy beaches?

Aruba's beaches have de-

veloped over the span of thousands of years. Waves crashing on the rocky formations along our coast line (which consists mainly of coral reefs) have started to wear and tear the reefs over time, resulting in its aradual breakdown. Fish that feed off corals also contribute to this, one small bite at a time. Over the course of thousands beaches in the south—the of years, as waves continue to crash and fish continue to eat off the corals, sand starts to accumulate around the area. However, whether the sand stays there is another question to be answered, and this is where we highlight the biggest difference between

the northern and southern coast of the island.

The sand that accumulates around a torn coral reef is swept away along with the debris by the ocean stream. However, in areas where it's shallow and the stream is weaker, the sand tends to sick to the bottom faster. This is why the areas with weaker stream shallower ocean that floors—has sand stretches for miles. In contrast, the northern area, where the stream is much stronger and the ocean floor is much deeper, there is no sand present—they were swept away with the


current!

Why north deep, but south shallow?

Ah! Good question...and interesting phrasing.

Aruba is a continental island. The island actually forms part of South America, and the space between Aruba and the South American continent is simply referred to as land that runs under the ocean. This is why it gets gradually deeper in the south, whereas the ocean floor in the north runs steeply to the bottom.

(Oranjestad)—At the furthest western point of the island, there lies the tallest structure on the island: The California Light House. Standing on top of a limestone cliff, this lighthouse oversees the entire island, offering one of few best views of the island and the surrounding sea. It is also one of the few monuments that hold a rich history.

The lighthouse was constructed in between 1914-1916, and its first keeper was a young trained lighthouse keeper from Curacao names Jacob Jacobs. Mr. Frederico Fingal was the last man to have occupied this position until 1962. Though his son, Mr. Romulo Fingal did not continue in his father's footsteps, he does have a special connection to the lighthouse. He sat down with our reporter and shared a bit of its history.

As Mr. Fingal explains, "In 1915, cargo donkeys were hired from Figaroa di Noord to help build the Lighthouse at Westpunt. The donkeys had to walk along the beach all the way to Westpunt carrying the cargo, poles, cement, and all these things. At that time, it was a difficult task until Aruba got its first truck.

These things reflect how people could have accomplished this tremendous job with so little." Mr. Fingal said, "At that time, it wasn't a place for people to work. It was very challenging because it was full of goats and donkeys, and it was very isolated. There were no hotels or roads to get there. There was only a donkey trail. Those were the only means of transportation."



Mr. Fingal continues, "In 1939, I was born in the lighthouse, and my father was the last lighthouse keeper until he retired in 1962. After that, they removed the power cables all the way to the top. According to the story, we couldn't have the light ourselves because they dismantled it, and after many years, I heard that it is in a train museum in San Nicolas, where we found this very special lens that, when the light shines through it, it reaches 30 kilometers out to sea." Mr. Fingal told our reporter.

The lighthouse has a long and very interesting history. The reason why the lighthouse was built, according to Mr. Fingal, dates back to the day when the cargo ship S.S. California sank because of the lack of light. In 1913, Aruba made a request to Curacao to build a Lighthouse at Westpunt, and the governor of Curacao responded to Aruba to come back in 1915 with a well-detailed plan. "During the First World War from 1914 to 1918, they had to wait for the light to be transported to Aruba because it was manufac-

tured in France. At that time, there was no electricity, and the light was very interesting because it rotated with a kerosene lamp that planes used; clean kerosene," Mr. Fingal said.

Mr. Fingal discovered something very interesting about the lighthouse after much research was documented in his book 'History of the Lighthouse at Westpunt.' He found many details: "I found out that the height of the lighthouse was due to the absence of electricity. There was also the presence of coral. There is a long steel cable from where the light is, and under the light, at the highest point, there is a hanging weight, a sort of pendulum that swings like that, with a weight that measures about 1 meter by 30 centimeters wide, which is a block of solid iron attached to a cable. When you release it upwards, it comes down, and the weight that comes down pulls it up, gradually. And while it comes down, the same weight that is descending causes many small wheels to turn in the opposite direction. The Lighthouse rotates from 6 pm in the evening, when the sun sets, until 6 am in the morning. During the entire night, the light shines on the lantern, it goes down 24 meters, and the Lighthouse is 30 meters high. It is designed not to collapse," Mr. Fingal explains.

Mr. Fingal further explains that in one night, the lighthouse rotates 4,320 times and consumes one gallon of kerosene for the whole operation. "At that time, the kerosene was supplied from the Lago refinery. Every day it was brought down, and to

start the light again, they had to lift the weight up, so our job as children was to crank it and raise the weight back up in the evening when the light stuck, they would take it down again, and the light stayed down. That's how it worked for a very long time," Mr. Fingal explains.

Thanks to the Monument Fund Aruba, which worked hard and is currently in charge of the Lighthouse, Mr. Fingal is very happy with its preservation, along with all the renovations that have taken place. He hopes that the story of the lighthouse will continue to live on for future generations.

Special announcement form the Monument Fund Aruba for 2025

Starting Monday, October 13th, until the end of 2025, the California Lighthouse will be closed to the public. The reasoning behind this is that the lighthouse is due for a major maintenance.

Stichting Monumentenfonds Aruba (SMFA) is the owner of the lighthouse and operates under a maintenance plan in which each year, different monuments belonging to the foundation receive upkeep. Recently, work was completed on the Casita Geel on Weststraat, and now it will continue with the California Lighthouse.

Due to the lighthouse's location and its daily use, it is one of the monuments that requires a lot of maintenance. The work is expected to last approximately two and a half months.



OpenAl faces 7 lawsuits claiming ChatGPT drove people to suicide, delusions

OpenAI is facing seven lawsuits claiming ChatGPT drove people to suicide and harmful delusions even when they had no prior mental health issues.

The lawsuits filed Thursday in California state courts allege wrongful death, assisted suicide, involuntary manslaughter and negligence. Filed on behalf of six adults and one teenager by the Social Media Victims Law Center and Tech Justice Law Project, the lawsuits claim that OpenAl knowingly released GPT-40 prematurely, despite internal warnings that it was danaerously sycophantic and psychologically manipulative. Four of the victims died by suicide.

The teenager, 17-year-old Amaurie Lacey, began using ChatGPT for help, according to the lawsuit filed in San Francisco Superior Court. But instead of helping, "the defective and inherently dangerous Chat-GPT product caused addiction, depression, and, eventually, counseled him on the most effective way to tie a noose and how long he would be able to "live without breathing."

"Amaurie's death was neither an accident nor a coincidence but rather the foreseeable consequence of OpenAI and Samuel Altman's intentional decision to curtail safety testing and rush ChatGPT onto the market," the lawsuit says.

OpenAI called the situations "incredibly heartbreaking" and said it was reviewing the court filings to understand the details.

Another lawsuit, filed by Alan Brooks, a 48-year-old in Ontario, Canada, claims that for more than two years ChatGPT worked as a "resource tool" for

Then, without warning, it changed, preying on his vulnerabilities and "manipulating, and inducing him to experience delusions. As a result, Allan, who had no prior mental health illness, was pulled into a mental

health crisis that resulted in devastating financial, reputational, and emotional harm."

"These lawsuits are about accountability for a product that was designed to blur the line between tool and companion all in the name of increasing user engagement and market share," said Matthew P. Bergman, founding attorney of the Social Media Victims Law Center, in a statement.

OpenAl, he added, "designed GPT-40 to emotionally entangle users, regardless of age, gender,

or background, and released it without the safeguards needed to protect them." By rushing its product to market without adequate safeguards in order to dominate the market and boost engagement, he said, OpenAI compromised safety and prioritized "emotional manipulation over ethical design."

In August, parents of 16-year-old Adam Raine sued OpenAI and its CEO Sam Altman, alleging that ChatGPT coached the California boy in planning and taking his own life earlier this year.

The shutdown has disrupted air travel. Will that drive a surge in car rentals and train bookings?

NEW YORK (AP) — The U.S. government shutdown has rattled air travel — most recently with an unprecedented effort from the Federal Aviation Administration to cut flights by 10% at airports nationwide. And the disruptions are causing some to instead hit the road or buy a train ticket. That could mean more and more business for car rentals, long-haul buses and commuter rails like Amtrak particularly if flight delays and cancellations continue piling up as the U.S. approaches Thanksgiving and other peak holiday travel. Amid the latest scramble, Hertz is already reporting a sharp increase in one-way car rentals. One-way reservations have spiked more that 20% through the com-

for travelers," Hertz CEO Gil West said in a statement. "Every day of delay creates unnecessary disruption." Amtrak, meanwhile, is predicting record Thanksgiving

numbers.

The rail service said it began to see those bookings grow before the shutdown began but told The Associated Press on Thursday that it was also "reasonable to

expect an increased share shift to Amtrak" if flight disruptions mount. Amtrak has maintained that its routes are running normally amid the shutdown.

Flix North America, the parent company of FlixBus and Greyhound, is also preparing for more demand.

"Our message is simple: you still have options," said Kai Boysan, CEO of Flix North America.

Boysan maintained that intercity buses are "one of the most dependable ways to get around" and not impacted by the shutdown like flights are. "We anticipate more travelers may turn to ground transportation in the days ahead, and we're monitoring demand closely and prepared to add capacity where needed to ensure people can keep moving," he added.

A Flix spokesperson said Friday that many of its bookings typically occur within 24 to 72 hours of departure, noting that the company should have a "clearer picture" of the overall impact in the coming days.

Still, train and bus routes are sometimes more available in certain parts of the country than others. And some have also encountered sold-out tickets or rentals in recent days instead turning to other creative options. Karen Soika from Green-

wich, Connecticut, found out Friday morning that her flight out of Newark, New Jersey, was rebooked for an hour earlier. But she later learned her plane was actually leaving from New York's John F. Kennedy International Airport instead, at least an hour away.

She unsuccessfully tried to book a rental car to get to Utah for a weekend trip, before settling on another option: booking a U-Haul. "I'm going to U-Haul and I'm going to drive a truck cross country," said Soika. Meanwhile, others are hoping to avoid lengthy

Lukoil said it agreed to the deal, pending some conditions including permission from the U.S. Treasury Department's Office of Foreign Assets Control, or OFAC. Terms of the deal were not specified.

On the same social media platform late Thursday, the Treasury Department alluded to Russian President Vladimir Putin's decision to send Russian troops to invade Ukraine in February 2022 and U.S. President Donald Trump's efforts to end the war, which has killed and injured hundreds of thousands of people.

"President Trump has been clear that the war must end immediately," the department's post on X said. "As long as Putin continues the senseless killings, the Kremlin's puppet, Gunvor, will never get a license to operate and profit."

Gunvor, in its post shortly afterward, said Treasury's statement about it was "fundamentally formed and false."

"Gunvor is and has always The company says Timbeen open and transpar- chenko is no longer afent about its ownership and business, and has for more than a decade actively distanced itself from Russia, stopped trading in line with sanctions, sold off Russian assets, and publicly condemned the war in Ukraine. Ukraine," the post said.

"We welcome the opportunity to ensure this clear misunderstanding is corrected. In the meantime, Gunvor withdraws its proposal for Lukoil's international assets," it added.

Gunvor was founded by Swedish oil magnate Torbjörn Törnqvist, its chairman, and Gennady Timchenko, an oligarch close to Putin. Its headquarters are in Nicosia, Cyprus.

NCAA revokes eligibility of 6 more college basketball players as it continues sports betting probe

The NCAA revoked the eligibility of six men's college basketball players on Friday as a result of three separate sports-betting cases that involved a powerconference school and allegations of players throwing games to lose by more points than the spread.The NCAA Committee on Infractions released findings from an investigation that concluded Chatton "BJ" Freeman at Arizona State; Cedquavious Hunter, Dyquavian Short and Jamond Vincent at New Orleans and Donovan Sanders and Alvin Stredic at Mississippi Valley State either manipulated their performances to lose games, not cover bet lines or ensure certain prop bets were reached, or provided information that enabled others to do so during the 2024-25 regular season.

The development comes as the sporting world contends with mounting scrutiny over betting. Nearly three dozen people were arrested last month, including an NBA player and coach, for what federal law enforcement officials described as their involvement in various illicit gambling activities. Just this week, UFC President and CEO Dana White said he was in touch with the FBI regarding a match that involved unusual betting pat-

For its part, the NCAA said last month it was investigat-

ing at least 30 current or former players for gambling allegations. The NCAA also banned three college basketball players in September for betting on their own games at Fresno State and San Jose State.

Arizona State is the only power-conference school involved in the recent announcements. Freeman became implicated in the investigation when the NCAA reviewed text messages between him and a player banned in September, Mykell Robinson, who played at Fresno State. Records on Robinson's phone indicated that on four separate occasions between November and December

2024, Freeman knowingly provided information to Robinson, who was betting on Freeman through daily fantasy sports accounts.

Freeman also knowingly provided information on at least two occasions to his then-girlfriend, who was also betting on Freeman.

In one instance, Freeman provided information to Robinson to bet the over on Freeman's turnover total against Florida on Dec. 14, 2024, according to the NCAA. Arizona State entered the game 8-1, having recently beaten two eventual-NCAA Tournament teams. The Sun Devils lost 83-66 to the ninth-ranked Gators, and went on to finish the season 13-20. Freeman had one turnover in the game.

Arizona State declined to comment on the case when contacted by The Associated Press.

The violations at New Orleans against Hunter, Short and Vincent came to light after the NCAA received a tip about game manipulation. The NCAA said a student-athlete overheard the three players discuss a third party placing a bet on their game against Mc-Neese State on Dec. 28, 2024. New Orleans lost 86-

That same student-athlete reported that during a timeout near the end of

the game, Short instructed him not to score any more points.

New Orleans suspended all three student-athletes for the remainder of the season while it investigated the allegations.

The NCAA investigation showed that the three players manipulated their performances in seven games from December through January to lose by more points than the spread for that game.

The NCAA reached out to an integrity monitoring service to review Mississippi Valley State games after a related, but separate NBA gambling ring that was uncovered earlier this year showed potential ties to college basketball, including the school.

The service indicated betting trends for the Mississippi Valley State games on Jan. 6 against Alabama A&M were suspicious. Mississippi Valley State lost 79-67.

During an interview with the NCAA, a men's basketball student-athlete said that before the team's Dec. 21, 2024, game, he overhead Sanders on the phone with an unknown third party talking about "throwing the game."

Sanders asked the studentathlete to participate in the call because the third party had told Sanders the individual intended to bet on the game and wanted to know that another of Sanders' teammates would participate in the scheme.

Sabalenka overcomes Anisimova and lines up Rybakina in title match at WTA **Finals**

RIYADH, Saudi Arabia (AP) — No. 1-ranked hours in a rematch of the U.S. Open final. Arvna Sabalenka reached the title match at the WTA Finals for the first time in three years after overcoming Amanda Anisimova 6-3, 3-6, 6-3 in the semifinals on Friday. Sabalenka will play first-time finalist Elena Rybakina on Saturday.

No. 6 Rybakina beat No. 5 Jessica Pegula 4-6, 6-4, 6-3 on the back of 15 aces.

Sabalenka was pushed to the brink by No. 4 Anisimova, who matched Sabalenka's power and aggression for more than two

Rybakina, the 2022 Wimbledon champion from Kazakhstan, has won all four of her matches this week, and clinched the win over Pegula on her first match point.

"It was not easy to come back but I'm glad I managed to find my way in the second set and win it in this three-sets battle," Rybakina said.

"The serve, when I needed it, helped me." Pegula reached the final in 2023.

PITTSBURGH (AP) — Jalen Ramsey wasn't kidding when he told Steelers head coach Mike Tomlin after arriving in a trade with Miami early last summer that he would do whatever was necessary to win.

The seven-time Pro Bowler and three-time All-Pro cornerback revisited the conversation with Tomlin last week ahead of a meeting with Indianapolis.

The Steelers and their struggling secondary were hurting, both figuratively and literally, after getting shredded in back-to-back weeks by Joe Flacco and Jordan Love.

DeShon Elliott was headed to injured reserve after hyperextending his right knee in a way that likely ended his season. Jabrill Peppers and Chuck Clark were battling health issues of their own. Veteran Juan Thornhill was struggling in coverage, and newly acquired Kyle Dugger had been in town for all of a day or two.

During a chat he described as "mutual," Ramsey, Tomlin and defensive coordinator Teryl Austin hatched a plan that moved one of the league's most respected defenders to safety — a position he hadn't played since his freshman year at Florida State, well over a decade ago — on an interim basis in hopes of providing some stability to a unit that had seen little of it during a frequently

rocky opening two months to the season.

The results were promising. With Ramsey allowed to roam a little more freely, Pittsburgh limited the NFL's highest-scoring offense to 20 points (half of them in garbage time) and forcing six turnovers to snap a twogame losing streak.

Ramsey figures to be on the back end again Sunday night in Los Angeles, where another difficult test awaits against Justin Herbert and the Chargers (6-3).

It's a job Ramsey is more than willing to do, just don't suggest he's ready to make the move there full-time like Hall of Famer Rod Woodson did late in his career.

"I'm on my own path," Ramsey said Friday. "So I'm embracing my own journey." One that has seen Ramsey go from Steelers tormentor — he was the linchpin of a young Jacksonville defense that stunned Pittsburgh in the divisional round of the 2017 playoffs — to a respected voice in a room filled with veterans like T.J. Watt and Cam Heyward, whose resumes rival Ramsey's save for the Super Bowl ring Ramsey won with the Los Angeles Rams in 2022.

With the Steelers wobbling after consecutive losses to Cincinnati and Green Bay, Tomlin asked Ramsey and

tight end Jonnu Smith to speak to the team ahead of the visit by the Colts. The exact contents of Ramsey's pep talk are a mystery. He declined to get into specifics about it, and his teammates offered little in the way of details except for Ramsey urging them to "play with an edge."

It's an edge that Ramsey has carried with him throughout his career, and one that has served a secondary in need of a new alpha after Pittsburgh sent Minkah Fitzpatrick to the Dolphins in exchange for Ramsey and Smith.

"Jalen leads in a different way, but you see his energy week in and week out," Hey-

ward said. "It's infectious." also necessary. Ramsey's intensity is buffeted by a high-level football IQ, one of the many reasons Tomlin and Austin felt comfortable approaching him about moonlighting at safety while Brandin Echols took on a larger role in the cornerback rotation.

"Whatever you need to do to win, he's all for," Austin said. "So, it was no problem. There was no kickback. It was actually like 'OK, Hey, what do you need me to do? Let's go."

As easy as Ramsey made it appear at times, he stressed it was not like riding a bike. It was challenging, but in a way that appealed to him. "Playing corner for 10 years, you kind of learn the game and it kind of becomes 'Same old, same old, same old' every day," he said.

It sounds like a humble brag. It's not. Sitting in meetings with the safeties over the last two weeks has been educational in a way that Ramsey didn't necessarily expect when he agreed to the assignment.

"I'm learning kind of new things to look at, different ways to look at the game from a safety's point of view," he said. "It's been cool."

Just don't expect it to be permanent. Ramsey still considers himself a shutdown corner. The safety thing is just a side gig still at this point in his career, though who knows what might await down the
