

Emails reveal Epstein's network of the rich and powerful despite sex offender status

Associated Press (AP)—By the time Jeffrey Epstein pleaded guilty in 2008 to soliciting prostitution from an underage girl, he had established an enormous network of wealthy and influential friends. Emails made public this week show the crime did little to diminish the desire of that network to stay connected to the financier.

Thousands of documents released by the House Oversight Committee on Wednesday offer a new glimpse into what Epstein's relationships with business executives, reporters, academics and political players looked like over a decade.

They start with messages he sent and received around the time he finished serving his Florida sentence in 2009 and continue until the months before his arrest on federal sex trafficking charges in 2019.


During that time, Epstein's network was eclectic, spanning the globe and political affiliations: from liberal academic Noam Chomsky to Steve Bannon, the longtime ally of President Donald Trump. Some reached out to support Epstein amid lawsuits and prosecutions, others sought introductions or advice on everything from dating to oil prices. One consulted him on how to respond to accusations of sexual harassment.

Epstein was charged with sex trafficking in 2019, and killed himself in jail a month later. Epstein's crimes, high-profile connections and jailhouse suicide have made the case a magnet for conspiracy theorists and online sleuths seeking proof of a cover-up.

The emails do not implicate his contacts in those alleged crimes. They instead paint a picture of Epstein's influence and connections over the years he was a registered sex offender.

Epstein kept a diverse political network

on all sides, sending news clips and discussing strategy or gossip often in short, choppy emails laden with spelling and grammatical errors.

In several emails in 2018, Epstein advised Bannon on his political tour of Europe that year. Bannon first forwarded Epstein a news clip that described the German media as "underestimating" Bannon and that he was "As Dangerous as Ever."

"luv it," Epstein responded. Epstein wrote that he'd just spoken to "one of the country leaders that we discussed" and that "we should lay out a strategy plan. how much fun." Several months later, Ep-

several months later, Epstein sent some advice: "If you are going to play here, you'll have to spend time, europe by remote doesn't work."

"its doable but time consuming," Epstein continued in a follow-up email, "there are many leaders of countries we can organize for you to have one on ones." Just a few months earlier, Epstein was insulting Trump

whose movement Bannon was a representative of in emails to Kathryn Ruemmler, the former White House counsel under President Barack Obama.

Ruemmler sent a message to Epstein calling Trump "so gross." A portion of that message was redacted, but Epstein replied, "worse in real life and upclose."

In other emails with Ruemmler, Epstein detailed a whirlwind of well-known people he appears to have been meeting, hosting or speaking with that week, including an ambassador, a tech giant, foreign business people, academics and a film director.

"you are a welcome guest at any," he wrote.

Jennifer Zuccarelli, a spokesperson for Goldman Sachs, where Ruemmler now works, declined to comment.

Epstein's wealthy socio

The financier emailed often with people in the upper echelons of wealth around the world, brokering introductions and chatting about politics and foreign

affairs.

That included Silicon Valley investor Peter Thiel, who Epstein sent an email to in 2014 saying "that was fun, see you in 3 weeks."

Four years later, Epstein asked if Thiel was enjoying Los Angeles, and, after Thiel said he couldn't complain, replied "Dec visit me Caribbean." It's unclear if Thiel ever responded.

In emails with Sultan Ahmed bin Sulayem, an Emirati businessman, Epstein complimented Bannon, saying in 2018 that "We have become friends you will like him."

"Trump doesn't like him," responded Sulayem.

A year earlier, Sulayem asked Epstein about an event where it appeared Trump would be in attendance, asking,

"Do you think it will be possible to shake hand with trump."

"Call to discuss," Epstein wrote back.

In January 2010, biotech venture capitalist Boris Nikolic was attending the annual World Economic Forum in Davos, Switzerland, and Epstein emailed to ask, "any fun?"

Nikolic replied that he had met "your friend" Bill Clinton, as well as then-French President Nicolas Sarkozy and "your other friend," Prince Andrew, "as he has some questions re microsoft."

But then Nikolic said he was getting sick of meetings. Later, he wrote Epstein that "it would be blast that you are here." He mentioned flirting with a 22-year-old woman.

"It turns out she is with her husand. Did not have chance to check him out. But as we concluded, anything good is rented;)" Nikolic wrote.

Epstein kept in touch with academics

The theoretical physicist and cosmologist Laurence Krauss was among them. In 2017, Krauss reached out to Epstein via email for advice on responding to a reporter writing a story about allegations of sexual harassment against him.

"Is this a reasonable response? Should i even respond? Could use advice," Krauss asked Epstein.

In an explicit exchange, Epstein asked Krauss if he'd had sex with the person in question and then suggested he should not reply to the journalist.

"No. We didn't have sex. Decided it wasn't a good idea," replied Krauss.

Krauss said in an email to The Associated Press that he never hid the fact that he knew Epstein, and interacted with him several times.

"I sought out advice from essentially everyone I knew when false allegations about me were circulated in the press in 2018," said Krauss. "I was as shocked as the rest of the world when he was arrested" in 2019.

In an August 2015 email exchange, Epstein told Chomsky, the famed linguist and social scientist, to only fly to Greece if he feels well, joking he previously had to send a plane for another "lefty friend" to see a doctor in New York.



Preliminary findings show a fatigue crack caused a Keystone Pipeline oil spill in North Dakota

By JACK DURA **Associated Press** BISMARCK, N.D. (AP) — A fatigue crack in the Keystone Pipeline led to an oil spill in North Dakota earlier this year that released thousands of barrels of oil

onto farmland, according to the pipeline operator. In a quarterly report released Thursday, South Bow said initial findings show, "the failure resulted from a fatigue crack that originated along the pipe's manufactured long-seam weld." A fatigue crack develops from stress over time. A mechanical and metallurgical analysis found the pipe and welds met industry standards, the company said. Spill-related costs total around \$55 million, which the company said it expects to recover through insurance early next year. Through September, South Bow had received about \$16 million in reimbursements from its insurance policies. The U.S. Pipeline

An estimated 3,500 barrels or 147,000 gallons of oil spilled in a field near Fort Ransom, a small town in a forested area with outdoor recreation and scenic views. South Bow sent vacuum trucks and more than 200 workers to aid the cleanup. The pipeline restarted after a six-day shutdown.

State regulators inspected the site several times in the months after the spill, noting in September that "the vegetation is recovering well," and that it should be checked again in spring 2026, according to an incident report.

Nearly 90% of the spilled oil was recovered, according to the report. Crews removed impacted soil to be disposed of elsewhere.

Local landowner Myron Hammer said South Bow's cleanup was completed in time for him to plant a soybean crop on the land.

"I'm surprised that they got everything put back in place as quick as they did. It was a big project," he said. Roughly 5 acres of land were impacted by the spill, though South Bow utilized 40 acres or more for the entire staging area and access, Hammer said. People and vehicles were on site as recently as Thursday, he said.

The area of the spill is in gently rolling farmland.

Man charged with 4 counts of murder in mass shooting at South Carolina bar

COLUMBIA, S.C. (AP) -Authorities have charged a man with murder in a mass shooting that killed four people and injured 15 more last month at a bar on a South Carolina island. Anferny Freeman, 27, was already in jail on a charge of possessing a machine gun when investigators served arrest warrants on him Friday, Beaufort County Sheriff P.J. Tanner said.

About 350 people were at a 25th high school reunion party in the early morning of Oct. 12 when gunfire broke out at Willie's Bar and representing him. Grill on St. Helena Island, deputies said.

"How all that happened is for a courtroom and not here," Tanner said.

19 migrants deported by US to Ghana have been moved to an unknown location, lawyer says

ACCRA, Ghana (AP) — Nineteen West African nationals deported by the U.S. to Ghana have been moved to an unknown location, a lawyer for one of the deportees said.

Ana Dionne-Lanier, who represents one of the nationals, told The Associated Press on Thursday the group arrived in Ghana on Nov. 5 and were put in a hotel. They are protected from deportation to their home countries due to the risk of torture, persecution or inhumane treatment, she said. "We don't know the location of any of them," Dionne-Lanier said, adding that neither she nor her client's family has been able

been sent to Africa from the U.S. since July after the Trump administration struck largely secretive agreements with at least five African nations including Eswatini, Rwanda and South Sudan to take migrants under a new third-country deportation program.

The Trump administration's deportation program has faced widespread criticism from human rights experts, who cite international protections for asylum-seekers and question whether immigrants will be appropriately screened before being deported.

The administration has been seeking ways to deter immigrants from entering the U.S. illegally and remove those who already have done so, especially those accused of crimes and including those who cannot easily be deported to their home countries.

South Africa investigates mystery of a plane that arrived with more than 150 Palestinians from Gaza

JOHANNESBURG (AP) -

South Africa's intelligence services are investigating who was behind a chartered plane that landed in Johannesburg with more than 150 Palestinians from war-ravaged Gaza who did not have proper travel documents and were held onboard on the tarmac for around 12 hours as a result, the country's president said

The plane landed Thursday morning at O.R. Tambo International Airport, but passengers were not allowed to disembark until late that night after immigration interviews with the Palestinians found they could not say where or how long they were staying in South Africa, South Africa's border agency said.

It said the Palestinians also did not have exit stamps or slips that would normally be issued by Israeli authorities to people leaving Gaza.

The actions of South African authorities in initially refusing to allow the passengers off the plane provoked fierce criticism from non-governmental organizations, who said the 153 Palestinians who included families with children and one woman who is nine months pregnant kept in dire conditions on the plane, which was extremely hot and had no food or water.

South African President Cyril Ramaphosa said there was an investigation to uncover how the Palestinians came to South Africa via a stopover in Nairobi, Kenya. "These are people from Gaza who somehow mysteriously were put on a plane that passed by Nairobi and came here," Ramaphosa said.

Palestinians being 'exploited'

The Palestinian Embassy in South Africa said in a statement the flight was arranged by "an unregistered and misleading organization that exploited the

tragic humanitarian conditions of our people in Gaza, deceived families, collected money from them, and facilitated their travel in an irregular and irresponsible manner. This entity later attempted to disown any responsibility once complications arose."

It didn't name who chartered the flight, but an Israeli military official, speaking anonymously to discuss confidential information, said an organization called Al-Majd arranged the transport of about 150 Palestinians from Gaza to South Africa.

The official said that Israel escorted buses organized by Al-Majd that brought Palestinians from a meeting point in the Gaza Strip to the Kerem Shalom crossing. Then buses from Al-Majd picked the Palestinians up and brought them to Ramon airport in Israel, where they were flown out of the country.

The secretive nature of the flight raised fears among rights groups that it marked an attempt by the Israeli government to push Palestinians from Gaza.

Israel's foreign ministry referred questions to the Coordinator of Government Activities in the Territories (COGAT), the Israeli authority responsible for implementing civilian policies in the Palestinian territories. It said the Palestinians on the charter plane left the Gaza Strip after it received approval from a third country to receive them as part of an Israeli government policy allowing Gaza residents to leave. It didn't name the

empty Gaza permanently of its more than 2 million Palestinians a plan rights groups said would amount to ethnic cleansing. At the time, Trump said they would not be allowed to return. Trump has since backed away from this plan and brokered a ceasefire between Israel and the militant group Hamas that allows Palestinians to remain in Gaza.

South African leader Ramaphosa said that it appeared the Palestinians who arrived in Johannesburg were being "flushed out" of Gaza, without elaborating. The comment followed allegations by two South African NGO representatives who claimed that Al-Majd was affiliated with Israel and working to remove Palestinians from Gaza. They offered no evidence for the claims and COGAT didn't respond to a request for comment on those allegations.

Gift of the Givers founder Imtiaz Sooliman, one of those to allege involvement by what he called "Israel's front organizations," said this was the second plane to arrive in South Africa in mysterious circumstances after one that landed with more than 170 Palestinians onboard on Oct. 28. The

arrival of that flight was not announced by authorities. Sooliman said the passengers on the latest plane did not initially know where they were going and were given no food for the two days it took to travel to Johannesburg.

"They were given nothing on the plane itself and this must be challenged and Sooliman investigated," said.

South Africa has long been a supporter of the Palestinian cause and a critic of Israel and has led the international pro-Palestinian movement by accusing Israel of committing genocide against Palestinians in Gaza in a highly contentious case at the United Nations' top court. Israel denies committing genocide and has denounced South Africa as the "legal arm" of Hamas.

The people that ended up in South Africa underlined the desperation of Palestinians following a two-year war that has killed more than 69,000 Palestinians, according to Gaza's Health Ministry, and reduced the territory to rubble. The ministry's death toll does not distinguish between militants and civilians, but it says more than half of those killed were women and children. A fragile ceasefire is in place.

An organization called Al-Majd Europe has previously been linked to facilitating travel for Palestinians out of Gaza. It describes itself on its website as a humanitarian organization founded in 2010 in Germany and based in Jerusalem that provides aid and rescue efforts to Muslim communities in conflict zones.

The website does not list office phone numbers or its exact address. It states that Al-Majd Europe works with a variety of organizations including 15 international agencies, but no organizations are listed and a "will be announced soon" message was displayed in that section on Friday.



Ex-Congolese rebel leader on trial for war crimes in Paris begins hunger strike

KINSHASA, Congo (AP) —

Ex-Congolese rebel leader Roger Lumbala began a hunger strike on Friday to protest his trial, which began this week over atrocities committed two decades ago during the Second Congo War.

Lumbala, who dismissed his lawyers and refused to appear in court after the first day of the trial on Wednesday claiming the French court has no legitimacy to try him, announced his hunger strike in a statement read by the head of the Paris criminal court, Marc Sommerer.

The ex-rebel leader has been charged with "criminal conspiracy to prepare crimes against humanity" and "complicity of crimes against humanity" during the conflict from 1998 to 2003.

He faces a possible sentence of life in prison. A verdict is expected Dec. 19 following the trial at the Paris criminal court.

Congo has been wracked by deadly conflict in its mineral-rich east since the 1990s, with more than 100 active armed groups. The conflict escalated earlier

this year when the M23 rebel group seized two key cities with the help of neighboring Rwandan forces.

The 67-year-old led the Congolese Rally for National Democracy, a rebel group backed by neighboring Uganda and accused of atrocities against civilians, particularly targeting the Nande and Bambuti ethnic minorities in eastern Congo in 2002 and 2003.

The group committed widespread torture, executions, rape, forced labor and sexual slavery, according to U.N. reports.

Lumbala was arrested in Paris in 2020 and indicted by a French court in 2023. His lawyers have claimed that the Congolese government made an extradition request to France.

Henri Thulliez, an attorney who represents the victims in the case, said Congo made a first extradition request in 2013 but it addressed Lumbala's alleged ties to the M23 rebel group, not the war crimes for which he is being pursued.

Pakistan arrests 4 militants in connection to suicide bombing at Islamabad court

ISLAMABAD (AP) — Pakistan on Friday announced the arrest of four militants over their alleged involvement in a deadly suicide bombing outside a district court in the capital, a breakthrough in an investigation launched after the attack killed 12 people and wounded 28 others.

The men are suspected members of the outlawed Tehrik-e-Taliban Pakistan,

or TTP, which is a separate group but closely allied to the Afghanistan Taliban. One of the suspects, Sajid Ullah, is believed to have handled the bomb used in the suicide attack on the court in Islamabad on Tuesday, the government said in a post on social media platform X.

The men were detained in a joint operation by the nation's Intelligence Bureau and Counter-Terrorism Department, the government said.

The arrests came a day after Pakistan's Interior Minister Mohsin Naqvi said Afghan nationals carried out suicide bombings in Islamabad and northwest Pakistan earlier this week.

Ullah told investigators that Saeed-ur-Rehman, a TTP commander, ordered the attack in Islamabad

through the Telegram messaging app. The commander, also known as Daadullah, sent Ullah photographs of the suicide bomber, an Afghanistan citizen, with orders to receive him after he crossed the border into Pakistan from Afghanistan, where he was a resident of Nangarhar province, the government said.

Ullah arranged accommodation for the attacker near Islamabad and later retrieved an explosive suicide vest from a graveyard in the northwestern city of Peshawar on Daadullah's instructions before transporting the vest to the capital, the government said. Daadullah, originally from

Pakistan's Bajaur region, is part of TTP's intelligence wing and currently hiding in Afghanistan, the government said.

Naqvi, Pakistan's interior minister, said Thursday that Afghan citizens were involved in the Islamabad bombing on Tuesday and an attack Monday in the northwestern city of Wana, where gunmen stormed a cadet college and began a gun battle that lasted nearly 20 hours. Three soldiers and all the attackers were killed.

The attacks underscored Pakistan's deteriorating security climate as the country faces a resuraence in militancy, increasingly fraught relations with Afghanistan's government in its capital, Kabul, and a fragile cross-border cease-

Until Tuesday's blast, Islamabad was considered safer than the country's northwest, which has suffered from repeated violence.

Of course, being one of the highest points easily accessible to locals and tourists, the California Light House hill not only offers a tremendous view of the sunset, but also a breath taking scenery of most of the island. In the distance you can spot all the hotels, the western shoreline and the wild waves that crash on the northern side of the island.

Manchebo & Eagle Beach

Speaking of the western shoreline, the best spots for viewing the sunset on the beach has to be either Manchebo Beach or at Eagle Beach, which stretch along the entire western coast of the island. The sunset on these beaches is truly breathtaking; the sky



and ocean look so big and spacious, and paired with the orange/pink hue of the sunset, the white sandy beaches and the soft sounds of waves crashing it can only be described as an experience!

Arashi Beach

Another beach that has to be considered as another great spot to view the sunset. Arashi Beach is the last beach you will find along the western coast line, just before you drive up the hill to the California Light House. A favorite for surfers and body boarders, the Arashi sky stretches out for miles, lending a spectacular canvas for the sun to create a masterpiece of orange, pink and purple

Hooiberg Hill

These last two options are for more active couples. If you and your partner like to hike, the Hooiberg Hill may be a great place for you to get your daily workout in and enjoy a beautiful view of the sunset and the island as a little reward. Climb on top the 587-step stairs and reach the top to enjoy this incredible scenery.

Casibari Rock Formation

If you're a rock climber, you might enjoy watching the sunset on top of the Casibari Rock Formation. It's no Yosemite, but it does offer a fun little exercise to get to the top. But if you prefer not to get your hands a little dirty, you can always use the stairs in the back. hue.

Birds of Aruba: Soaring through the blue skies

(Oranjestad)—Aruba's nature is very diverse and is home to several beautiful and majestic wildlife. Among these is the bright Trupial, whose angelic voice is always heard with the rising sun; the cuddly parakeet, always in company of another, and the majestic Warawara, a mighty bird that can be seen soaring in the clear blue skies.

But don't let their angelic songs fools you; the Trupial can be a bit aggressive towards any threat, protective over their nesting spots nesting spots they most likely stole from other birds. The Brown-throated Prikichi (Aratinga pertinax) became the national




request of Aruba Birdlife Conservation. The bright green, adorable parakeet usually flies in flock of 30 or more, but its population has been declining since the 2010s. Prikichis are a shier breed than the trupial, often flying away at the sign of any threat. They use termite nests for breeding spots and feed mostly on seeds from the Kwihi tree, Divi Divi tree and fruits.

Warawara

The Warawara or Caracara is one of the biggest birds found in the Aruban mondi. At a heigh of 41 to 60 cm, their wingspan can measure up to 125 cm. Known as the "garbage man", this bird of prey mostly feeds on dead animals. Its coat is dark brown, with a creamcolored neck, orange face, thick beak and long legs. The Warawara prefers to build its nest in the middle of tall cacti and produces a rattling, screaming sound, throw-



ing its head back onto its back while calling.

While these birds are a beautiful sight to behold, it is very important to keep your distance and respect their habitats. This is how we protect our wildlife. By admiring the beauty of Aruba in a safe and respectful manner, we can do our part in protecting our sacred nature.

The Bushiribana Gold Mill Ruins and its history



(Oranjestad)—The Bushiribana Gold Mill Ruins is one of the most visited places by tourists on the island. as it lies along the northern coast line near the mini pool and on the way to the Natural Bridge. Despite its seemingly plain appearance, this ruin represents one of the most important histories of the island: The Aruban Gold Rush.

Built in 1872 by English company Aruba Island Gold Mining Company Ltd, the

gold mill at Bushiribana was constructed in the area where most gold was found by locals. The story of gold on Aruba actually dates back to 1725, when a first exploration for gold on the island was commissioned by the Dutch West India Company. Under the leadership of Mr. Paulus Printz, a three-year search was conducted on Aruba, to no avail. Though they found some gold, it was enough to motivate a further search, and the assign-

Printz himself.

It wasn't until 100 years later, in 1824, when a young boy found a lump of gold while out herding his father's sheep. His father took it to a local merchant who then sold the lump for \$70. Unbeknownst to the boy and his father, they quite literally struck gold, and as word got out, a gold fever spread among the locals who started searching for more gold. About 25 pounds worth was found.

At the same time, the Aruban government took immediate actions, and informed Curacao that gold was found. At first, everyone could look for gold, as long as they sold it to the government. However, after some time, the government decided to implement stricter rules and banned local search parties.

ment was discontinued by Over the years, concessionholding had seen different companies from around the world, all of which used primitive methods to dig and carve out gold from the rocks. Aruba Island Gold Mining Company Ltd. was no different, but used a unique method that involved grinding the rocks and letting the dust be blown away by the strong northeast wind, leaving clumps of gold behind. The

next step was melting the gold and letting it attach to quicksilver in order to obtain pure gold. All these processes were done at the Bushiribana Gold Mill.

The gold mill itself had a short life-span: only 10 years in service, but its structure remained relatively solid till this day, and is now a historical remnant.

(Oranjestad)—Among the endless sea of dark brown sand and cacti, there are two caves hidden in the outskirts of San Nicolas, in the north-eastern area of the island. These caves, The Quadiriki cave and The Fontein Cave are open to visitors of the Arikok National Park, so if you ever decide to take an "off-road" tour in the park, be sure to visit these prehistoric caves.

Quadirikiri Cave

Known for its two chambers accompanied by a skylight, the Quadikiri Cave is the most popular cave among locals and tourists, as it is easy to walk through and provides great lighting for pictures.

As with all prehistoric or ancient sites, there is always a folk legend that adds to the lore and mystery of the site. The Quadirikiri cave is no different. The most well-known legend behind the cave could be considered as Aruba's first love story, as it tells the tale of the undying love between the chief's daughter and her beloved. As legend would

have it, the chief disapproved of his daughter's choice of lover, as he thought him unworthy. Stubborn and filled with anger, the daughter refused to turn away her beloved.

So, the chief decided to lock her up in the Quadirikiri Cave, in hopes that she would soon calm down and turn away her lover. Her be-



Longer than the Quadirikiri Cave, the Fontein Cave contains pathways that stretch to the limestone walls further down. Here is also where prehistoric drawings can be seen. Though this cave does not



have its own legend, this was speculated to have been occupied—or at least used by prehistoric Arawak settlers on the island for rituals and other spiritual ceremonies.

The Huliba Cave/ Tunnel of Love

The Huliba Cave, formerly known as the Tunnel of Love, was once open to the public, and was the biggest and most accessible of all three caves. This cave had five chambers, including one that is heart-shaped. This cave had narrow stairs that led to long pathways deep into the cave, with a staircase leading to the exit on the other side. In one of the chambers, there used to be the carving of the Virgin Mary, put there for the protection of the cave.

However, the Huliba Cave has been permanently closed for a few years now, as a way to preserve the bat population that lives in the cave. These Long Tongue Fruit Bats and Insect Eater Bats are very important to the ecosystem of the island. Though this cave is no longer accessible to the public, it surely is interesting to learn more about the history of these caves and the Arawak tribes that resided or utilized them.

Do note that these caves are very dark, humid, hot, and are inhabited by bats. Do wear comfortable clothing and shoes, as the pathways in these caves may be rough and bumpy. Take care to not disturb the bats' habitat.





Lessons from our elders: Plants and fruits for medicinal use

medicine is now widely used for common illnesses and to keep our bodies healthy and happy, it is still very common in every household in Aruba (and around the world) to have staple home remedies that is passed on through generations. Here are some tips that our elders have passed on to us over the years.

Sweet potato

According to our elders, sweet potato is mostly useful for low blood pressure. People who suffer from low blood pressure were advised to eat sweet potato 2 to 3 times a week. However, if you have high blood pressure, it is best not to eat too much sweet potato, as this

(Oranjestad)— Though western raises blood pressure. Sweet potatoes are also great for people who work hard labor jobs, and it's been said to be aid blood circulation in the body, as well as help those with hemorrhoids or diarrhea.

> Many of our elders opted to plant sweet potatoes themselves, mostly because of how easy it was to do so. Cut the end of a sweet potato let it sit in shallow water until it starts to sprout. Then you may plant it in the ground. Sweet potatoes need plenty of water to grow, especially in the first week in the ground. It was said that once you start to notice the ground crack underneath the flowers, it is time to harvest. This should happen around month 3.



Pomegranate

Pomegranates are also one of the easier fruits to plant and harvest. Originated from Persia, this plant can grow almost everywhere. In Aruba, there are many homes that have a tiny or big pomegranate tree. You may be wondering what the difference is between a small and big pomegranate tree, for which the answer is based on harvest time. Tiny trees produce tinier pomegranates that can be harvested early on. Contrarily, big trees produce bigger pomegranates, but they need enough time to fully ripen before harvesting, otherwise you might end up with bitter seeds. Pomegranate trees are also very easy to plant. In es-

sence, if you just throw the seeds on the ground, they could grow into a tree.

In terms of medicinal use, pomegranate skins are said to have a few benefits for our health. According to customs, pomegranate skin tea can help those that suffer from diarrhea. Dried pomegranate skin tea is also good for people who have worms. Pomegranate flowers can be boiled to make a drink and this can be used for irritated gums; just take a swig and let the tea sit in your mouth for a couple minutes.



Arawak-Indian origin. A (or Ha) is an Indo-Antillean generalizing word. If you were to change a part of the word "Ayo", namely 'Yo', to 'Yu' and make 'Ayu', it would mean "white."

However, as we now know, the name of the neighborhood is 'Ayo'. The word 'Yo' stands for Yocahu, which is another word for 'creator' in Arawak/Taino and in the Papiamento spoken today, 'Ayo' means 'bye'.

The district of Savaneta: A quick history guide to the island's first capital

(Oranjestad)—Before Oranjestad became the island nation's capital, Aruba's first capital was the district of Savaneta. Here is where the cultural identity of Aruba was born, and from where the rest of the island developed into what it is today.

Savaneta is said to have been the first place where the Caquetio inhabitants first stepped foot on the island. Though there isn't hard evidence to back this up, but considering the legend of the Cacique Arua, it is believed that there were already movements on Aruba—and Savaneta—around 88 AD.

The Caquetios probably made their way to the island either from Venezuela, Colombia or other Caribbean islands in the region, but with good weather it was relatively easy for them to travel back and forth in their canoes. So, since the Caquetios discovered the island, Aruba found her first form of civilization.

It wasn't until 1499 when Aruba met another group of people who set foot on the island: the Spanish explorer Alonso de Ojeda. De Ojeda first took notice of Aruba off the coast of Venezuela, during his exploration of the Latin American country. This was on August 9th, 1499. However, de Ojeda didn't actually sail to the island till 4 days later, on August 23rd, 1499. This was the beginning of the Spanish era on Aruba (1499-1636).

Alonso usually didn't stop at every island or land he saw, especially not in the Caribbean. He would often take





notice of land from afar and continue sailing. However, Aruba was an exception. He had heard that there were "quebracho" (Kibrahacha) trees on the island, which were commonly used to produce dye or paint. But since these trees could not be found in Savaneta, he continued to search in the area of what is now known as Santa Cruz. The best way to transport the tree barks was via a route passing through Savaneta, and so the first road between Savaneta and Santa Cruz was made.

The Dutch colonial era (1636-1805) During the 80-year war between The Netherlands and Spain, Dutch explorers and merchants began to travel to the ABC islands. Once they landed in Aruba, they deported the small Arawakan and Spanish community that was living on the island. This was the beginning of colonization of the ABC islands by the Dutch empire. Around the same, the West Indian Company (WIC) was born. Bonaire and Curacao were mostly used for plantations, where the Dutch had transported slaves from Africa. Aruba, on the other hand, was mostly used to raise cattle and to house the haring factory. The

Dutch had often forced the indigenous community to work for them.

In 1636, when the Netherlands won the war against Spain, the country surrendered the islands to the Dutch.

The Dutch administration appointed the island's first commander, an Irish man named N. Williams. Because the Dutch were interested in other Caribbean islands and countries in South America, they imported Dutch merchants and business men, all of whom resided in Savaneta. This way, Savaneta officially became the island's

first capital.

However, at the end of the 18th century, the commander at the time, J.R. Lauffer, moved his office to what is now "Horse Bay" in Oranjestad. Because the highest office on the island moved away from Savaneta, the capital lost its title to what was called then Playa.

How Savaneta got its name The name Savaneta probably has a Spanish origin. It was said that when the Spanish climbed a hill called Yara, they saw that the area was mostly open and had no big trees. In Spanish, such a land area is called a "sabana".

Because of its land surface, Savaneta was a great place to construct cattle farms. From here, the farmer culture on Aruba was born. Before the Aruban Gold Rush and the construction of the Refinery in San Nicolas, most residents were farmers, and Savaneta had many inhabitants that farmed fruits and vegetables. They also continued the tradition of raising cattle, like goat, sheep, pigs and horses. Savaneta was one of the first places on the island to have a general farming culture. From this culture, many other traditions were born, like the Dera Gay Holiday that we celebrate every year on June 24th.



Helpful tips for your stay on Aruba

(Oranjestad)—When traveling to another country, especially for the first time, it is always better to be over-prepared than under-prepared. That is why we have a list of basicbut important information that we think may come in handy to Aruba's visitors.



Electrical power

Aruba generally operates on 110V to 127V supply voltage and 60Hz. There are also three types of outlets used on the island: type A with two flat prongs; type B with two flat and one grounding prong, and on occasion, type F with two round prong and two earth clips on the side. However, Type A is most commonly found in homes and establishments.



Supermarket hours

Supermarket hours may vary depending on where you are staying on the island. Generally though, most supermarkets are open from 8am to 8 or 10pm, Monday through Saturday. On Sundays, supermarkets generally close earlier; mostly around 2pm.



Drinking water

The water that flows through the sinks of every house, hotels and other establishments is distilled and perfectly safe to drink. Aruba's drinking water exceeds WHO's international standards for water quality, so there is no need to buy bottled water from the store.



Safety

Since February 2024, Aruba has been categorized as the safest country in the Caribbean by The Telegraph, and many tourist that visit have often told us how they feel safe to explore the island or walk around at night. However, rare incidents do occurs, so keep yourself and your belongings safe.

Opioid settlement with OxyContin maker Purdue and Sackler family could end years of legal battles

NEW YORK (AP) — Lawyers representing OxyContin maker Purdue Pharma, cities, states, counties, Native American tribes, people with addiction and others across the U.S. delivered a nearly unanimous message for a bankruptcy court judge Friday: Approve a plan to settle thousands of opioid-related lawsuits against the company and members of the Sackler family who own it.

If U.S. Bankruptcy Judge Sean Lane abides, it will close a long chapter and maybe the entire book on a legal odyssey over efforts to hold the company to account for its role in an opioid crisis connected to 900,000 deaths in the U.S. since 1999, including deaths from heroin and illicit fentanyl.

Friday's closing arguments were wrapping up a three-day hearing over the bankruptcy plan for the company, which filed for protection six years ago as it faced lawsuits with claims that grew to trillions of dollars.

Marshall Huebner, a lawyer for Purdue, told the judge that he wishes he could "conjure up \$40 trillion or \$100 trillion to compensate those who have suffered unfathomable loss." But without that possibility, he said: "The plan is entirely lawful, does the greatest good for the greatest number in the shortest available timeframe."

The opposition is much quieter this time around

The saga has been emotional and full of contentious arguments between the many groups that took Purdue to court, often exposing a possible mismatch between the quest for justice and the practical role of bankruptcy court.

The U.S. Supreme Court rejected a previous deal because it said it was improper for Sackler family members to receive immunity from lawsuits over opioids. In the new arrangement, entities who don't opt into the settlement can



Suriname and Curacao move closer to historic World Cup qualification

PARAMARIBO, Suriname (AP) — Richonell Margaret scored twice in two-minute span in the second half on Thursday as Suriname defeated El Salvador 4-0 in CONCACAF qualifying to move closer to securing a spot in the World Cup for the first time.

Tjaronn Cherry opened the scoring with a penalty kick in the 44th minute and Richonell Margaret scored in the 74th and 76th minutes while Dhoraso Moreo Klass added a goal in the 83rd.

With the win, Suriname remains undefeated and reached nine points in Group A, the same as Panama which defeated Guatemala 3-2.

Suriname, that has a better goal difference over the Panamanians, will visit Guatemala next Tuesday, while Panama hosts El Salvador.

Twelve teams, divided into three groups, are vying for three direct spots from regional qualifying for next year's World Cup. The United States, Canada and

Hojgaard leads World Tour Championship with McIlroy among Ryder Cup stars in pursuit

DUBAI, United Arab Emirates (AP) — Nicolai Hojgaard moved into position to win the season-ending World Tour Championship for a second time by taking a three-stroke lead on Friday, though a slew of Europe's Ryder Cup stars were well placed to pounce.

The chasing pack included Rory McIlroy, whose brilliant short game salvaged a 69 in the second round that kept him on track to capture a fourth straight yearlong Race to Dubai title for being Europe's No. 1 player. McIlroy was tied for second place in a five-man group that included Justin Rose (67) and Shane Lowry (67). Fellow Ryder Cuppers Robert MacIntrye (67) and Tommy Fleetwood (71) were a further stroke back and Tyrrell Hatton (67) one

more shot adrift.

They were all looking up at the 70th-ranked Hojgaard, who didn't make the Ryder Cup team this time that honor fell to his twin brother, Rasmus but is showing a reminder of his ability at the

Earth Course this week. The 24-year-old Dane shot 65, the low round of the day, to back up his opening 67 and was 12 under for the week. Hojgaard won the tournament in 2023, didn't qualify for it last year,

"It's one of my favorite tournaments to play," Hojgaard said. "It's great to be back in a bit of form.

"It suits my eye. It plays into my strengths, which is midirons. It's just a really good fit for me."

McIlroy stays patient

McIlroy mixed six birdies with three bogeys on a day when he was poor by his Hatton, who is five behind standards off the tee but his wedge play was magical. "I felt like I showed my scoring skills today, and battled well and stayed patient, and got the ball up and down when I needed to." McIlroy said. "And overall, to shoot 69, I'm pretty

pleased considering some of the spots that I found myself."

Alongside McIlroy, Lowry and Rose in a tie for second was Rasmus Neergaard-Petersen (67) and Daniel Hillier (68).

Only Marco Penge and Hatton second and third in the Race to Dubai standings, respectively overhaul McIlroy this week. Penge (70) appears out of it in 44th place, 12 shots off the lead, so only Hatton can realistically stop the Northern Irishman.

Hojgaard, needs to win and for McIlroy to finish worse than tied for eighth with one other.

Ohtani is unanimous MVP for 4th time in winning NL honor as Judge edges Raleigh for 3rd AL accolade

Associated Press (AP)— Shohei Ohtani likes winning Most Valuable Player awards. He loves winning the World Series even more. The two-way Japanese star did both for a second season in a row for the Los Angeles Dodgers, earning his fourth career MVP on Thursday night while unanimously earning the National League honor. He's just the second to win four MVPs after Barry Bonds with seven and the only player to win unanimously more than once.

Considering Ohtani is 31, overtaking Bonds doesn't seem out of the question. Especially if it leads to more Fall Classic opportunities.

"If I'm playing well as an individual that means I'm helping the team win, so in that sense, hopefully I can end up with a couple more MVPs," Ohtani said through an interpreter. "But at the end of the day, it's all about winning games." In the American League, Aaron Judge became the New York Yankees' fourth three-time winner, edging Seattle's Cal Raleigh with 17 first-place votes to 13 for the switch-hitting catcher. The vote was the closest Angeles Angels' Mike Trout topped Houston's Alex Bregman by 17-13 in 2019. Judge, who won the AL the fans in New York."

award in 2022 and 2024, joined Joe DiMaggio, Yogi Berra and Mickey Mantle as three-time MVPs with the Yankees. The 33-year-old outfielder led the majors with a .331 batting average and 1.144 OPS while hitting 53 homers.

When asked about his place in MLB and Yankees lore, Judge acknowledged he's in rare company.

"It's tough for me to wrap my head around," Judge said. "It's mind blowing for an MVP since the Los from my side of things, because I play this game to win, I play this game for my teammates, my family, all

Later he added: "You've got to pinch yourself every single day. It's truly an incredible honor."

Ohtani won a MVP for the third straight year, his second in the NL with the Dodgers after two in the AL with the Angels. He became the first to win in each league twice after getting the AL honor in 2021 and 2023. Ohtani signed with the crosstown Dodgers the following offseason and won NL MVP in 2024 during his first season in Chavez Ravine. He's also won the World Series in both his seasons with the Dodgers.

Philadelphia Phillies slug-

ger Kyle Schwarber finished second in the NL with 23 second-place votes and New York Mets outfielder Juan Soto was third with

Ohtani hit .282 and led the NL with a 1.014 OPS. He also had 55 homers, 102 RBIs and 20 stolen bases.

The right-hander returned to pitching in June after missing 1 1/2 seasons on the mound because of an elbow injury. He struck out 62 batters over 47 innings, slowly increasing his workload while preparing for the postseason.

Ohtani continued to shine in October with arguably

the greatest single game in MLB history. He hit three homers while striking out 10 over six dominant innings on Oct. 17, leading the Dodgers over Milwaukee to finish an NL Championship Series sweep.

Schwarber, who earned a \$50,000 bonus for finishing second, hit an NL-best 56 homers and led the big leagues with 132 RBIs for Philadelphia.

Soto overcame a slow start to the season to have his typically stellar offensive output. The four-time All-Star who signed a \$765 million, 15-year deal last December had 43 homers, 105 RBIs and an NL-best 38 stolen bases. He received a \$150,000 bonus for finishing third in the MVP voting.

Judge is the first AL player to win back-to-back MVPs since Detroit's Miguel Cabrera it in 2012 and 2013.

Raleigh, nicknamed "Big Dumper," led the big leagues with 60 homers, the most for a player primarily a catcher. He started 119 games behind the plate and another 38 at designated hitter.

The 28-year-old also had a career-high 125 RBIs, leading the Mariners to one of their best seasons in franchise history.

Judge said he got to know Raleigh a little during the All-Star break and the catcher asked for some leadership tips.

After a scintillating tussle with Jannik Sinner, Alcaraz secured the ranking on Thursday by sealing a sweep of his three groupstage matches at the ATP Finals.

The 22-year-old Spaniard was presented with the trophy at the Inalpi Arena in Turin, shortly before Sinner's match against Ben Shelton. "It's a great pleasure for me to be No. 1 in the world again," Alcaraz said. "It's something that I'm working really hard for, with my team every day. It is a goal, to be honest, but I think it is a journey that you're not going through alone.

"It's with your whole team, with your family, with your close people behind you, always supporting you, in the tough and in the good moments."

It is the second time in his career that Alcaraz has ended the year at the top of the rankinas.

He became the youngest player to finish a year at No. 1 when he achieved the feat as a 19-year-old in 2022.

"Having this trophy once again, the first one back in 2022, I have the same team. I'm still really proud of the team that I have right now," Alcaraz added.

"So for me, it's a great achievement. It means the world to me, to be honest, and I'm just really proud and happy."

Conor Benn seeks revenge against Chris Eubank Jr. in British boxing family feud

LONDON (AP) — Nigel Benn came up short against Chris Eubank twice in the early 1990s.

Conor Benn plans to take advantage of his second chance against Chris Eubank Jr. when the sons square off again Saturday in the latest edition of British boxing's biggest family feud.

The duo will meet again at the Tottenham Hotspur Stadium in a scheduled middleweight 12-round bout nearly seven months after their first fight a slugfest that Eubank Jr. won by unanimous decision.

"I genuinely thought I would knock you out in three rounds," the 29-yearold Benn said at Thursday's press conference. "I almost did, and I'm not going to let you go this time Chris." Eubank Sr. beat Nigel Benn with a ninth-round stoppage in 1990 to take the WBO middleweight title. The rematch three years later drew more than 16 million U.K. viewers on freeto-air ITV and ended in a

split-decision draw.

In late April, Eubank (35-3, 25 KOs) handed Benn (23-1, 14 KOs) his first professional loss. All three judges scored the fight 116-112.

"The truth is we both ended up in hospital," the 36-year-

old Eubank Jr. said Thursday. "I was there for dehydration. You were there for the beating you took."

Benn, usually a welterweight, came up two divisions for the fight.

"You got beat up by a welterweight," he told Eubank Jr. "Did you see your face? Has any other middleweight done that to you?"

They were originally set to fight in 2022 but it was canceled after Benn's voluntary urine test showed trace amounts of the fertility drug Clomiphene, a banned substance that boosts testosterone levels

In the buildup to the first fight, Eubank Jr. smacked an egg on Benn's face. Eubank Jr. then weighed in half an ounce (14 grams) over the 160-pound (72.5-kilogram) limit. That meant he had to pay a fine of \$500,000 to Benn, who said he used the money to buy a Rolls-Royce.

Neither have held a major world title.

Illegal bets in the Dominican Republic come under scrutiny after **MLB** pitchers arrested

By MARTÍN ADAMES **Associated Press** SANTO DOMINGO, Dominican Republic (AP) — Baseball and bets go hand-inhand in the Dominican Republic, where professional athletes, musicians and even legislators go public with their wagers.

But for every legal bet in the Caribbean country, officials say there are countless more illegal ones.

It's a widespread, multimillion-dollar industry that has come under scrutiny following U.S. federal indictments of Cleveland Guardians pitchers Emmanuel Clase and Luis Ortiz. They are accused of taking bribes from unnamed sports bettors in the Dominican Republic to throw certain pitches and help those bettors win at least \$460,000, according

to an indictment unsealed Sunday in New York. Ortiz and Clase have both pleaded not guilty.

The accusations have dismayed and embarrassed many in the players' native country.

"The case of Emmanuel Clase and Luis Ortiz tarnishes the image of Dominican baseball players," said José de los Santos, a fan of Dominican and Major League Baseball. "Actions of that nature put Domini-
